- (b) Council grants to the Executive Director: Community Services and Health, or any other official duly authorised in terms of the Systems of Delegations and in consultation with Legal Services, the authority to enter into and sign contracts and other documents, with or without financial consequences, with the "Friends" groups, businesses, communities, donors and other departments as envisaged by the Parks Development Policy, or its successor(s)-in-title
- (c) Council grants to the Executive Director: Community Services and Health the authority to conclude an agreement with Friends of groups across the City and to allow that such agreements include the right to achieve revenue streams from the Council facilities to be derived from their management of the sites in order to ensure sustainable management and maintenance of these spaces

4. DISCUSSION

The aim of the City's Parks Development Policy ("Policy") is the development of parks which address the needs of communities and to ensure sustainability of park developments within the context of scarce and limited resources.

A key Policy Directive prescribes that the Recreation and Parks Department ("Department") shall promote and facilitate collaboration in the design, development and maintenance of parks with inter alia "Friends" Groups. The Department must also ensure that suitable formal agreements are prepared and signed by all parties to mitigate risk and promote collaboration that are to be reviewed periodically in line with the City's Delegations.

There are currently forty-one (41) "Friends" Groups related to parks in the City, varying in size and function, assisting the Department with the management of its parks at no cost. These groups not only make a valuable contribution to the management of parks but also create a sense of involvement and ownership by the community. The nature and composition of these "Friends" Groups vary from individuals to registered Non-Profit Organisations ("NPO's"). Functions performed by the "Friends" Groups include:

- Monitoring and reporting illegal activity, incidents and maintenance requirements;
- Locking and unlocking of gates in line with opening and closing times;
- Performing basic tasks and operational activities including basic maintenance and cleaning etc.;
- Assisting with the safeguarding, and facility monitoring;
- Liaising with officials with regards to risks, operational shortcomings and possible projects or future plans;
- In some instances, creating employment opportunities for local workers or technical experts;
- Raising funds or other resources to implement local projects;
- Providing subject matter expert advice and guidance;
- Hosting awareness programmes and organising events.

In accordance with the Policy, the Department has embarked on a regularisation process to ensure that formal agreements are in place between the City and "Friends" Groups. The Department has engaged the City's Legal Services Department and a standard agreement template has been developed that would define the scope, rights and duties of the parties.

Based on this standard template, the City's Legal Services Department has drafted an agreement with the Friends of Van Riebeeck Park, Cape Town, and this report seeks authority for the conclusion of the agreement by the Executive Director: Community Services and Health.

The draft agreement is attached marked annexure "A".

Authority is also sought for the Executive Director: Community Services and Health to conclude the agreements with the "Friends" Groups and other relevant entities referred to in the Policy. The Policy stipulates that the Department "...shall promote and facilitate collaborations in the development and maintenance of parks with "Friends" groups, businesses, communities, donors and other departments, provided that there are mutual benefits and that adequate consultation has occurred with the community." It stipulates further that the Department "...shall ensure that suitable formal agreements, for example, partnerships or memoranda of agreements, are prepared and signed by all parties to mitigate risk and promote collaboration, and that these are reviewed periodically in line with the City's delegations."

There has been ongoing engagement with community representatives over several years regarding the establishment of A Friends of Van Riebeeck Park forum, with formal public participation engagements also taking place in the form of public meetings on 2 August 2016 at Herzlia High School, on 15 March 2017 at Herzlia High School and on 17 October 2018 at Good Hope Seminary.
