<p>The London School of Economics and Political Science (LSE) is a public research university in London. The LSE hosts several executive education programmes, of which the Data Science programme is one.</p> <p>The UK Foreign and Commonwealth Office (FCO) is a department of the UK government. The Prosperity Fund is a global fund of the UK government, the objectives of which are to promote development and prosperity through trade, promoting global growth and supporting resilience.</p>	

4. OBJECTIVE

The City of Cape Town is receiving technical assistance via the FCO Prosperity Fund (Future Cities Programme) to support the implementation of the Data Strategy. As part of this support, the City and the FCO identified the need for high quality, short course training in Data Science. The FCO identified an executive education programme and the London School of Economics as being suitable and, as part of the technical assistance to the City, offered to send Mr Cole and Mr Kesson on this programme.

Mr Kesson and Mr Cole are the officials responsible for designing and leading the technical assistance programme in support of the data strategy. Mr Kesson is the Chief Data Officer for the City and the sponsor for the technical assistance programme. Mr Cole is the director responsible for the technical assistance programme.

Mr Kesson and Mr Cole are best placed to give leadership on the development and use of data science capacity in the City. Data science is a complex, emerging field where there is significant hype, over promising and misunderstanding, particularly in solving public policy challenges. But with the correct strategies and implementation, data science has the potential to enable government service delivery and drive efficiencies.

The objective of sending two senior CCT officials on the Data Science programme was:

1. To equip the officials to guide City policy and implementation relating to data science
2. To learn about effective short course training approaches on data science, with a view to working with the FCO to develop such training in Cape Town
3. To consolidate and build the relationship with the FCO

5. OUTCOMES

The principle outcome of the week at the LSE was learning on the use of data science to further the objectives of the City. Gaining this sort of international, high quality learning on data science would have been prohibitively expensive without the support of the FCO.

The secondary outcome, which is yet to be realised, may be the development of data science learning options for other city government officials in South Africa.

In the process of identifying and participating in this opportunity, the City has further built its relationship with the FCO as a strategic partner.

A useful by-product of this trip was that the Mr Cole was able to further strengthen the relationship between the City and the London School of Economics. This was done through engaging the academic staff delivering the data science programme and through delivery of an evening policy seminar for the School of Public Policy at LSE.
