## MINUTES

OF A MEETING OF SUBCOUNCIL 10 OF THE CITY OF CAPE TOWN HELD IN THE  
KHAYELITSHA TRAINING CENTRE ON FRIDAY, 16 AUGUST 2019 AT 10:00

**STANDARD BUSINESS****10SUB 1/8/2019 OPENING AND PRAYER/MOMENT OF SILENCE**

The Chairperson welcomed everybody present at the meeting and said today's meeting is a little bit awkward for him as their monthly subcouncil meetings normally takes place on Mondays, he then declared the meeting open.

**10SUB 2/8/2019 APOLOGIES/LEAVE OF ABSENCE**

That the leave of absence for Ald. Landingwe and Cllr Badela **BE NOTED** subject to the Chief Whips approval.

**10SUB 3/8/2019 CONFIRMATION OF MINUTES**

Prior to confirmation of minutes, Cllr Cassim said they are a quite a lot of errors and he said, he does understand that, the English is not the first language of the minute taker and asked if the minute taker can be assisted in order the minutes can be more accurate through City scaling and, said that will assist the minute taker in future.

That the minutes of the meeting held on the 14 June 2019 **BE CONFIRMED**, subject to the following corrections.

The Chairperson welcomed officials, members of the KCT and members of the public present at the meeting, and declared the meeting opened.

Ald Landingwe informed the meeting that, Cllr Gabuza will join the meeting later. Prior to noting that Cllr Gabuza will be arriving late, the Chairperson informed the meeting that this was the 2<sup>nd</sup> meeting where the EFF was not represented after the National Elections. He informed councillors that Cllr Botya who was representing the EFF had joined the Provincial Legislature.

That the meeting **NOTE** that Cllr Gabuza will be joining the meeting later.

Prior to the adoption of the minutes, Cllr Mbolombo raised a concern, about the way the minutes were taken. He said the meeting should note that not everything discussed was captured in the minutes. The Chairperson asked, Cllr Mbolombo to be specific about what was not being minuted. He said that if the minutes were checked page by page it will be seen that not everything was captured. He said that it seemed as though the minute taker was being selective when taking minutes as some comments were not captured.

Cllr Peter asked the chair to call Cllr Mbolombo to order. Cllr Ngcani agreed with Cllr Peter and said that Cllr Mbolombo could not say that the minutes were not

correctly captured because he could not share with the meeting which part of the minutes was not captured correctly.

Cllr Badela moved as follows: That the minutes of the meeting held on the 20 May 2019 **BE CONFIRMED** subject to the following corrections.

That on pg. 12 of the minutes, under the subheading Transport, the last sentence should read as, "These two projects are important in respect of the viability of Khayelitsha."

That on pg. 12 under subheading **Zenvlei Sewerage Plant**, it should read as **"Zandvliet Sewerage plant"**.

That under subheading EPWP opportunities, the last sentence should read as "Khayelitsha was most affected by the unemployment and underdevelopment. We must look at the stats, not **these**".

That on page 14, under Cllr Cassim's comments, the word **triarch** be corrected to **"triage"**.

## MATTERS RECEIVING ATTENTION

Prior to attending to MRA's, the Chairperson informed the meeting that the interpreter for the meeting was Ms Fula. He encouraged councillors to speak in the language of their choice as the interpreter was bilingual. The Chairperson reminded the meeting that it was resolved in full council that the motion from Cllr Cassim regarding the expansion of Spine road in the Khayelitsha CBD be supported. He asked the meeting whether this matter could become a standing item on the agenda. This was agreed to.

The Subcouncil Manager informed the meeting that the motion on Spine Road expansion by Cllr Cassim had been escalated to the office of the director. He reported that the motion was sitting in the MRA for more than 299 days.

On the issue of distributing title deeds, he reported that this was ongoing. As from the 1<sup>st</sup> of July, a budget was going to be available for handing out title deeds to beneficiaries.

Lastly, he said that the matter of the upgrade of Spine road and developments in CBD were part of the agenda.

## CHAIRPERSON REPORT

### 1. Introduction

The sub-council meeting was declared open. Councillors, officials and members of the public present; were welcomed to the Sub-Council 10 meeting. This was the last month before the beginning of the new financial year which starts on 01<sup>st</sup> July 2019. Our biggest concern will always be the ward allocations expenditure. The update as far as that was concerned showed that we were on track with the expenditure.

All councillors were afforded an opportunity to reflect on their respective wards regarding expenditure relating to their respective ward allocation. The meeting heard that there were two areas of concern: boxing equipment in ward 98 and sports equipment in ward 97 had not yet been procured and delivered. An update was required from the manager pertaining to the delivery of the items mentioned above.

The chairman reported that he had attended a meeting a week earlier of all sub-council chairpersons. A performance report was shared at that meeting. He was

pleased to report that sub-council 10 was in the top ten best-performing sub councils with regards to ward allocation expenditure. Sub-council 10 had spent 85% of its ward allocations. However, some invoices had not yet been processed. When that was done, the score would improve even more. That, he reported, gave him comfort because it showed that councillors were taking their responsibilities seriously.

He then asked the meeting to recall that the item on Zandvliet sewerage plant expansion was in the previous month's agenda. It was agreed then that this project be supported to continue without any disruption as various housing projects like MANAMA and others were dependent on the expansion being completed. Zandvliet was presently operating at full capacity. It was therefore important for councillors in this sub-council to jealously safeguard this project.

**10SUB     MATTERS RECEIVING ATTENTION**  
**4/8/2019**

Prior to matters receiving attention, Chairperson Cllr Mngxunyeni welcomed newly appointed EFF Cllr Linda Mazwi and introduced himself, Subcouncil Manager and, the rest of councillors and wish her well in her deployment in Subcouncil 10 and, said the office will provide a name tag for her. He welcomed and thanked Ald. Twigg who is a Mayco member for Urban Management in Area East for attending today's subcouncil meeting.

The Manger informed the meeting that, the first matter in matters receiving attention, is a motion from Cllr Cassim which is sitting at 344 days, Cllr Cassim contested the statement made by the manager by informing the meeting that, the motion is actually 809 days, the Subcouncil manager then asked, if it is 809 days how many years if converted into years. Cllr Cassim said it is 2 years to be exact.

The Subcouncil Manager informed the meeting that, Greg Oelofse said the motion does not belong to his department, and said the responsible official given by Greg Oelofse is Ms. Erica Henrietta. Manager said Ms. Erica even wrote an email asking if she can have one on one with Cllr Cassim and that did not happen, the manager then escalated the matter to the new Executive director's Asmal Osman asking for assistance with regard to the motion and even copied Ms. Erica but she has not responded.

Cllr Cassim proposed proposed that, the meeting supports the motion that he circulated at the meeting for the long overdue motion, see attached motion.

Cllr Mbolompo said he does not understand why the motion has not been dealt with as it was approved by full Council. He said was happy seeing the removal of containers at the back of Lingeletu Police station.

**10SUB CHAIRPERSON REPORT  
5/8/2019**

## 1. Introduction

The sub council meeting was declared open; councilors, officials and members of the public present; were welcomed for attending the Sub-Council 10 meeting.

There are various issues that affects us as a sub-council, in order to ensure that we play a role in servicing our people effectively. These issues are intertwined and ranges from crime to public lighting; unattended C3 notifications to ward allocations, and I would unpack them as we progress.

## 2. Challenges

### 2.1 C3 Notifications

There's a serious matter of unattended C3 notifications and we've been highlighting this now for quite some time. We have raised the snail pace response of officials in fixing potholes in our respective wards. Cllr. Cassim's motion speaks to this and Cllr. Peter also raised this issue at one of our sub council meetings. The official must be invited to the sub-council activities day to provide answers. Due to rainy weather this has worsened.

### 2.2 Public Lighting

I'm glad manager that you mentioned of the official from public lighting. This has been our biggest concerns as reports of street lighting not working properly have not been attended to promptly. This contributes to high crime rate which is the biggest concern of this sub council.

### 2.3 Crime

The criminal activities affecting schools and other essential services in Khayelitsha remains our biggest concern. We are getting reports from schools that are being threatened by criminals. It has worsened that criminals are now are visiting clinics and robbing the staff. Clinics also get robbed of medicines and ambulances need to be escorted to attend emergency situation in our community. This situation is worrying. I know that councilors sitting here are trying to assist the situation by allocation funds for neighborhood watch in striving to make the communities safer. Cllr. Twigg as the Mayco member responsible for urban management must assist us with crime prevention mechanisms, particularly now that it is affecting public services.

### 2.4 Ward Allocation

This is our second month on the new financial year, and I would like to request councilors to pay special attention to ward allocation implementation, jealously. We must ensure whilst early that we prevent a situation where we do not spend our allocation. If we act early that situation could be mitigated. I know very well that in the past we managed to have spent all our funds, keep up the good work councilors.

As I have indicated that my input would not be long as the items we have raised on previous sittings form part of today's agenda.

### **SUB-COUNCIL 10 CHAIRPERSON'S REPORT - COMMENTS**

**Cllr. Cassim:** Last night, I attended ward 49 meeting and they are facing similar issues, especially on crime related issues where people are robbed. They resolved to have tighter communities by forming street committees and street committee forum. Since this resolution, they've noticed a great deal of improvement.

Cllr. Twigg is here, he can have a bite especially on walking bus which assists children to go and return from school safely. If we encourage the formation of street committees and street forums we might see improvements.

**Cllr. Mbolompo:** I must thank your address chair, especially that it mentions neighborhood watch. We must deal with crime decisively. We need to encourage our ward councilors to invest more on neighborhood watch, and I'm happy that there is a consistent allocation on this on all our ward councilors in this regard. We need to encourage a compulsory amount of R150,000 on NHW every financial year to ensure that we deal with crime decisively.

I'm disappointed that you failed to mention the issue of Marikana, where people died in August 2012. I was expecting a moment of silence in respect of mineworkers that died on that day. I understand that this occurred while we are governed by the ANC, hence the difficulty in recognizing this like other massacres happened during the apartheid era.

**Cllr. Gabuza:** The councilor sitting next to me (Cllr. Mbolompo) is out of order; he needs to learn to be guided by your input not raise issues that we not part of your input.

I welcome your input, especially around the issue of crime in Khayelitsha and street lighting. MURP has set aside a budget on this, and can assist us in fighting crime.

**Chairperson:** The issue raised by Cllr. Mbolompo was not on my address, hence I doubt that he had taken time to familiarize himself with the agenda. There are number of important presentations to be presented here, so he must not waste our time.

**Cllr. Peter:** Greetings to all present, members of the public; protocol of the sub-council observed; the chairperson, the manager and the visiting councilor, Cllr. Twigg. Let me further welcome your input chairperson.

I just want to raise one issue, for things to happen in this sub council, should it be by means of motions raised? Through chairperson report, we have raised the issue of potholes and this is the burning issue. On public meetings, our community is raising the issue of potholes sharply, and they are not happy with the condition of Khayelitsha roads.

Therefore, we cannot act like giraffes and stretch our necks beyond our territory

like the issue of Marikana; we will be missing the point, we need to focus on pertinent issues of service delivery to the community of Khayelitsha.

Crime is a serious matter that affects us and our community on daily basis, before we look at Marikana. The councilor from the governing party want us to spend R150,000 from ward allocation for NHW, whereas nothing is set aside on capital budget for this issue. I raised this sharply even on my portfolio committee that, everything we do in our various ward we do so from ward allocations of R850, 000 that has now been increased to R1 million.

We even came with an innovation of clubbing together our ward allocation so that we could have significant projects in our wards, nothing is coming from the City of Cape Town capital budget to assist us except this ward allocation that is expected to do everything.

Crime will remain an issue if other departments, like community safety are not assisting. Ward allocation is meant to be spread across community issues not only on crime, if City is serious enough about crime in Khayelitsha then this department must contribute the remaining R100,000 to make the R150, 000 that Cllr. Mbolombo is talking about. This goes to other departments of the City that they need make resources available to ensure that Khayelitsha is serviced effectively as a community.

I welcome Cllr. Cassim's views on street committees, and I want to remind him that we have been doing so long before 1994. However, the issue of overpopulation and apartheid spatial planning of Khayelitsha and other townships had adversely impacted us on organizing tighter communities. The high crime rates in townships is by design, hence it is an unfair comparison to compare our community to ward 49. We have a serious situation of unattended backyarders by the City which also contributes to overpopulation that is the breeding ground for criminal activity.

The community of ward 92 is failed by the City on fighting crime. On our meeting with the city police, they indicated a personnel shortage; then how do you fight crime? The issue of containers selling drugs at the corner of Makabeni and Spine took the City ages to finally remove those containers; then how do you fight crime when you raise issue with the City and no action is taken? There also similar containers next to Khayelitsha station that are selling drugs to our kids but they are still there.

We do not want these containers in our community as they perpetuate criminality in our society and we would not shy away from that even when some community members are getting rent fees from those containers. We will not rest until all illegal containers are removed. I am happy that department of safety had finally acted in community's favour.

**Cllr. Cassim:** Last night in the ward committee, I heard that registered NHW were given two-way radios by the City. On today's Cape Argus, it's reported that Khayelitsha only got R1.8 million for City lighting out of R62.5 million budgeted, hence crime rate is high in Khayelitsha. It also says that the City admits that lack of lighting contributes to crime in Khayelitsha.



**Chairperson:** The issue of crime is our biggest worrying factor. It has been reported that there are roving cars robbing and shooting people at night across Khayelitsha. This is a challenge for us as leadership to resolve. The sooner we put our heads together and act; the better. As I have mentioned before that we worry every time you getting in and out of your own house and we cannot be living in fear, something must be done.

At another level, we proposed for a crime summit to devise crime prevention strategies in Khayelitsha. The sooner we have this summit the better.

Mr. Feni gave a brief background, he said Interland started 2015 and had a vision of building an upmarket mall in Khayelitsha. He said they are here to enhance the economy of the township and said they have met with KDF. He said he said the mall will be built in ward 92 over the railway line and opposite the Khayelitsha Hospital.

Mr. Eugene Jnr. added that the mall will be enclosed and plans have been

submitted and if approved the mall will commence 1<sup>st</sup> September 2019. He said the proposed name for the mall is Ikwezi Mall.

- Cllr Peter welcomes the presentation and said she was never consulted but Mr. Sipakisi did mention the new mall and said naming the new mall Ikwezi is contracting and said in Khayelitsha there is an area called Ikwezi one would think the mall will be built there

Ms. Josephs from the coastal informed the meeting about the demolition of derelict coastal infrastructure on the False Bay and Atlantic coastlines, she said the department seeks to obtain approval for the demolition by the City of Cape Town, of derelict coastal infrastructure on the False Bay and Atlantic Coastlines. She mentioned the following ervens' to be demolished erf 1142 Strand, erf 485, 498-Re, 472 Macassar, Farm 544-Re Monwabisi; erf 87374-Re Sonwabe; erf 4459-Re Simon's Town; Farm 798-Re Witsand; and erf 3400-Re Table View.

- Cllr Cassim asked if the material can be given to the people within the community to take what they want, instead of the department spending about R 10 million in demolishing an old building that is no longer in use
- Cllr Peter welcomed the presentation and said, it is long overdue that, finally something is going to be done at Monwabisi beach and said it is been years since, the community of Khayelitsha has been pleading that, Monwabisi beach be renovated to the standards of blue flag beaches, she asked the

presenter what are the future plans after it is demolished and said she hopes that it will be re-built as a recreation facility as the community of Khayelitsha is in need of a high standard beach.

- Ms. Josephs said the amount of R10 million is not meant only for Monwabisi beach it is a quote for all the old City structures that, will be demolished and said about future plans she will ask her manager and forward a response to the subcouncil.
