## PLEASE NOTE: LANGUAGE POLICY OF THE CITY OF CAPE TOWN

Council on 27 November 2002 adopted a language policy for the City of Cape Town, which *inter alia* requires that:

1. **all resolutions** of the Council, its Subcouncils and Committees must be available in all three languages,
2. reports submitted to Council, its Subcouncils and Committees must be kept in the original form submitted. However, the **recommendations** to all reports must be made available in all three official languages, and
3. **notices of all meetings and indexes to agendas** must be in all three official languages.

Certain operational aspects/requirements imposed by the policy will be phased-in one of these being the establishment of a Language Department to give effect to the policy.

It is to be noted that Committee Services is making every effort to uphold the key principles embodied in the policy, namely, to promote multilingualism and to give increasing effect to the equal status/use of the three official languages of the Western Cape (Afrikaans, Xhosa and English) by providing (1) interpreter services at meetings where required, (2) translations of recommendations and **indexes** contained in agendas, and (3) translations of resolutions/recommendations contained in minutes of Council, its Subcouncils and Committees. However, until the Language Department is fully operational it may not always be possible to give effect to the requirements of the policy as set out in paragraphs 1 to 3 above.

## NCEDA QAPHELA: UMGAQONQUBO WOLWIMI WESIXEKO SASEKAPA

Nge-27 kaNovemba 2002, iBhunga liye lamkela umgaqo-nkqubo woLwimi weSixeko saseKapa, onyazelisa ezi zinto zilandelayo:

1. **zonke iziqqibo** zeBhunga, namaBhungana alo kwakunye nezeeKomiti mazikhutshwe ngeelwimi zontathu,
2. iingxelo ezingeniswe kwiBhunga, kumaBhungana alo nakwiiKomiti mazigcinwe ngolwimi ebezingeniswe ngalo. Kodwa, **izindululo** zazo zonke iingxelo kufuneka zikhutshwe ngazo zontathu iilwimi ezipemthethweni zeli phondo, yaye
3. **izaziso zazo zonke iintlanganiso nezalathiso (i-indeksi) zeajenda** mazensiwe ngeelwimi zaseburhulumenteni zontathu.

Ezinye iimfuno zokusebenza ezinyanzeliswa ngulo mgaqo-nkqubo ziza kuthotelwa ngokuhamba kwexesha, enye yazo, ikukuba kumiselwe iSebe leeLwimi ukuze lo mgaqo-nkqubo ukwazi ukusebenza.

Kufuneka ithathelwe ingqalelo into yokuba iINkonzo zeKomiti zenza konke okusemandleni ukuphakamisa iinjongo ezipambili zalo mgaqo-nkqubo, ukutsho oko, ukukhuthazwa kokusetyenzisa kweelwimi ezinini ukunyusa ifuthe lokulinganisa kwezinga leelwimi zonke/ukusetyenzisa kweelwimi ezintathu ezipemthethweni eNtshona Koloni ezizezi (isiBhulu, isiXhosa nesiNgesi) ngokubonelela (1) ngeenkonzo zokutolika kwintlanganiso xa oko kuyimfuneko, (2) uguqulo iweezindululo nezalathiso ezipulethwe kwiajenda, kwakunye (3) noguqulo iweeziggibo/izindululo ezipulethwe kwimizuzu yeentlanganiso zeBhunga, aMabhungana alo kwakunye neeKomiti. Noxa kunjalo, de iSebe leeLwimi libe liyasebenza ngokupheleleyo, akuzi kusoloko kukwazeka ukuba kuthotelwe iimfuno zomgaqo-nkqubo nanjengoko kuchaziwe kwimihlathi 1 ukuya kowesi-3 apha ngentla.

## LET OP ASSEBLIEF: TAALBELEID VAN DIE STAD KAAPSTAD

Die Raad het op 27 November 2002 'n taalbeleid vir die Stad Kaapstad aanvaar, wat onder andere vereis dat:

1. **alle besluite van die Raad, sy subrade en komitees in al drie tale beskikbaar moet wees;**
2. verslae voorgelê aan die Raad, sy subrade en komitees in die vorm waarop dit oorspronklik ingedien is, voorgelê moet word. Die **aanbevelings** tot alle verslae moet egter in al drie amptelike tale beskikbaar gestel word; en
3. **kennisgewings van alle vergaderings en indekse tot agendas** moet in al drie amptelike tale wees.

Sekere bedryfsaspekte/vereistes wat deur die beleid gestel word, sal ingefaseer word. Een daarvan is die stigting van 'n taaldepartement om uitvoering te gee aan die beleid.

Kennis moet geneem word dat Komiteedienste hul bes doen om die sleutelbeginsels omvat in die beleid te handhaaf, naamlik om veeltaligheid te bevorder en om toenemend uitvoering te gee aan die gelyke status van die drie amptelike tale van die Wes-Kaap (Afrikaans, Xhosa en Engels) deur die verskaffing van (1) tolkdienste by alle vergaderings indien verlang , (2) vertalings van subrade en komitees. Totdat die taaldepartement ten volle in werking is, sal dit egter nie altyd moontlik wees om uitvoering te gee aan al die vereistes van die beleid soos uiteengesit in paragraaf 1 tot 3 hierbo nie.
