During 2019, a review of the City of Cape Town Climate Change Policy was carried out. This review process determined that the Policy required significant updating in order to ensure that it remained in line with new scientific findings regarding climate change as well as significantly increased global ambition towards addressing climate change.

Additionally, it was determined that the Policy should be upgraded and converted into a City of Cape Town Climate Change Strategy in order to provide a higher level of strategic guidance for decision-makers.

The draft Climate Change Strategy has been drafted by a multi-disciplinary drafting team, including representation from the following departments: Environmental Management, Sustainable Energy Markets, Policy and Strategy, Resilience, and Enterprise and Investment.

Additionally, summaries of the draft Climate Change Strategy in English, Afrikaans, and Xhosa are attached as Annexures B, C, and D, respectively. The public participation plan for the draft Climate Change Strategy was sent to all subcouncils during August, and is attached here as Annexure E for reference.

## 7. DISCUSSION/CONTENTS

During 2019, a review of the City of Cape Town Climate Change Policy was carried out. This review process determined that the Policy required significant updating in order to ensure that it remained in line with new scientific findings regarding climate change as well as significantly increased global ambition towards addressing climate change.

Additionally, it was determined that the Policy should be upgraded and converted into a City of Cape Town Climate Change Strategy in order to provide a higher level of strategic guidance for decision-makers. Together with the City's Resilience Strategy, the new Climate Change Strategy will give meaning to the City's commitment of being a connected, climate adaptive and carbon neutral city, achievable through partnerships, scaled response and public ownership and action.

Addressing climate change requires a whole of city approach that will require City departments to collaborate effectively. Through a dedicated strategy, the City will be able to design a framework for such collaboration, and for the development of an integrated approach to climate change, recognizing that it is a key socio-economic risk, and not just an environmental issue. Additionally, the current Policy deals with a broad range of high level issues that are better suited for the Strategy level.

It is the vision of the draft Climate Change Strategy to create an urban environment that is climate resilient, resource efficient and carbon neutral. Acting now to address climate change will enable inclusive economic and social development and environmental sustainability. It is also important to note that effectively addressing climate change requires collaboration, co-operation, and partnerships.

The key aims of the draft Climate Change Strategy are as follows:

- To provide a framework for the City to transform the way it plans and operates and to ensure alignment of key City policies, strategies, and plans with climate change concerns while guiding directorates and departments through this transition;
- To ensure that the co-benefits of climate change adaptation and mitigation including job creation, improved health, reduced risk, improved energy and
  water security, and a range of other benefits are maximised in the
  implementation of the strategy;
- To address identified impacts within the City's mandates and spheres of influence and to ensure that the City is able to address the challenges posed by climate change and;
- To ensure the local economy can trade competitively in a global environment that is rapidly rejecting carbon intensive goods and services.

The draft Climate Change Strategy has been drafted by a multi-disciplinary drafting team, including representation from the following departments: Environmental Management, Sustainable Energy Markets, Policy and Strategy, Resilience, and Enterprise and Investment.

The draft Climate Change Strategy is attached as Annexure A. Additionally, summaries of the draft Climate Change Strategy in English, Afrikaans, and Xhosa are attached as Annexures B, C, and D, respectively. The public participation plan for

the draft Climate Change Strategy was sent to all subcouncils during August, and is attached here as Annexure E for reference.

# 7.1. Constitutional and Policy Implications

The current City of Cape Town Climate Change Policy states the following vision: "To become a city that is climate resilient, resource efficient and lower carbon, in order to enable sustainable and inclusive economic and social development, and environmental sustainability."

The conversion of the Climate Change Policy to a Climate Change Strategy is in line with the goals of the Climate Change Policy and will enhance the implementation of these goals by elevating climate change response to the Strategy level.
