DRAFT MOTION FOR TABLING AT THE SUB-COUNCIL 10 MEETING OF 16 August 2019

Whereas the IMF has slashed SA's GDP growth forecast to less than 1% after the weak first quarter growth;

And whereas job losses are on the increase and widespread on account of declining economic opportunities and flight of capital;

And whereas it is incumbent on us as councillors to recognise the danger of the rapidly shrinking economy and the impact of that on societal wellbeing and harmony,

Therefore, considering the above economic scenario, Sub Council 10, moves with haste to do all in its power jointly with other partners to stimulate economic growth within Khayelitsha and surrounding areas and accordingly undertakes to utilise an Activity Day to get accredited community leaders together to—

- 1. consider where economic opportunities exist in Khayelitsha and the surrounding areas and to determine what those opportunities look like;
- 2. create a consultative group to drive economic growth and this group will comprise two representatives from each community organisation that has a valid constitution, verifiable membership in good standing and which has been operating from at least June 2016 and has been accredited through a stipulated ward process;
- find consensus with duly elected community role players on giving support to fast track big projects being proposed to the city in order to create maximum economic opportunities for the people of Kyayelitsha and adjoining areas;
- 4. determine what principles communities want developers to subscribe to in order to give their support for the envisaged developments and to ensure that no project is delayed and no project is abandoned;
- 4. use all means of communication available to the sub-council to draw the attention of the community to development ideas that are being canvassed and to make them aware of all economic proposals so that they are kept fully in the loop and in this regard the local radio station should be used extensively; and
- 5. ensure that all projects which have had the support of the sub-council and the full council get off the ground quickly and within the period stipulated to allow for continuous creation of jobs and other economic opportunities.
