SYNOPSIS

OF A VIRTUAL MEETING WITH THE SPEAKER, CHAIRPERSON AND WARD COUNCILLOR AND SUBCOUNCIL MANAGER REGARDING RENEWAL OF LIQUOR LICENCE APPLICATION ON SITE: CUBANA, WCP 037297, UNIT1, 12 BEACH BOULEVARD, TABLEVIEW ON 06 JANUARY 2021 AT 09:00 – 09:10 AND RESUMED AT 15:00 – 15:47.

The Chairperson greeted everyone present at the meeting and said that the item for discussion was the application for renewal of extension of liquor trading hours from 11:00 – 04:00 Mondays to Sundays: Cubana Tableview: WCP/037287, situated at Unit 1, 12 Beach Boulevard, Tableview, 7441, to which the Chairperson and Ward Councillor and Subcouncil Manager should comment and recommend under delegated authority, Delegation 4(1) & (2).

It was noted that the letter from the Health Department dated 18 December 2020, indicated the incorrect Liquor License Number and should read: WCP/ 037287 and not WCP/033985.

During the discussion with Ms Bettie Leedo (Head: Department of Health), it was determined that Cubana Tableview did not renew their liquor licence WCP/033985 situated at Erf4557, 9 North Point Centre, Portfield Road, Table View, 7441 but instead took over a Certificate of Transfer of the previous traders, Medley'z, situated at Unit 1, 12 Beach Boulevard, Table View, 7441 under Liquor Licence WCP/037297.

Cubana Tableview subsequently closed their premises at 9 North Point Centre, Portfield Road, Table View and re-opened their business at Unit 1, 12 Beach Boulevard, Table View on 6 December 2019.

The Certificate of Transfer dated 12 November 2019 – pages 10 - 11 of the application is included on pages 5 & 6 of this synopsis.

It must therefore be taken into account that the liquor licence previously in the name of Medley'z, Ref WCP/033985 applied for extended trading hours during 2018, after which it was refused by the Subcouncil as well as the Appeals Committee. Therefore, Medley'z trading hours remained 11:00 – 02:00.

Understanding from the Ms Leedo's remarks, Cubana could not transfer the trading hours: Sundays – Thursdays 11:00 – 02:00 and Fridays, Saturdays and Public Holidays 11:00 – 04:00 to the new Liquor Licence WCP033985 that only caters for trading hours from 11:00 – 02:00 Mondays to Sundays.

Ms Leedo therefore said that Cubana's application must be seen as a **new** application for extension of trading hours under Liquor License Ref: WCP/033985 situated at Unit 1,12 Beach Boulevard, Table View, 7441 and not as an application for the renewal of their previous Liquor Licence WCP/037297 situated at 9 North Point Centre, Portfield Road, Table View, 7441.

COMMENTS FROM THE CHAIRPERSON AND WARD COUNCILLOR, CLLR NICOLETTE RHEEDER:

Cllr N Rheeder presented her comments and recommendation after due consideration of all the received objections as well as all the appropriate legislation in regard to the application for extended trading hours for Cubana, Table View as discussed and decided in the meeting.

Cllr N Rheeder recommended that the trading hours for Cubana be Sunday to Thursday from 11h00 until 02h00 and Friday, Saturday and Public Holidays from 11h00 – 02h00 for the reasons set out below:

- There have been 10 objections to the application that have been taken into consideration.
- The establishment is less than 20m from a residential block of apartments containing 53 units and the surrounding area, in close proximity, contains predominantly residential properties zoned GR1, 2, 3 and SR1.
- According to the Control of Undertakings that Sell Liquor to the Public By-Law 2013, a business premises in a Local business or neighbourhood business area including mixed use areas as well as a general business area has a maximum permitted hours of trade from 11h00 – 02h00.
- The Alcohol Harms Reduction Paper (AHRP) aims to make our communities safer and our opportunities greater, by minimising **alcohol** consumption and **reducing** unnecessary **harm** to individuals, families and society as a whole. Alcohol is the most commonly abused drug countrywide. In 2013, it was recognised as the 3rd leading risk factor for death and disability in South Africa, following unsafe sex and obesity. It's also a dominant substance of abuse in the Western Cape. Cases of Foetal Alcohol Spectrum Disorder recorded in the Western Cape are among the highest in the country. Statistics show that 70% of trauma victims in our hospitals test positive for alcohol. As a City we need to assist with the aims of the AHRP.
- The current pandemic confirms the accuracy of the statistics mention in the previous point with regards to trauma victims in hospitals. Once the ban on the sale of alcohol was implemented there was an immediate and significant decrease in the numbers of alcohol related trauma injuries which hospitals treated.

Taken into account the above discussion it was decided that the Chairperson and Ward Councillor and Subcouncil Manager resolved to recommend the application for the extension of trading hours for Cubana Table View, Unit 1, 12 Beach Boulevard, Table View, 7441, to Mondays to Thursdays 11:00 – 02:00 and Fri, Sat and PH 11:00 – 02:00.

Subcouncil 3 considered the application for extended trading hours (onconsumption) and resolved as follows:

Sundays to Thursdays 11:00 – 02:00 and Fridays, Saturdays and Public holidays 11:00 to 02:00, subject to the following conditions:

- (a) That the application for the renewal of extended trading hours (off-consumption) submitted by Cubana Tableview, Unit 1, 12 Beach Boulevard, Tableview, 7441, be considered as it complies with the criteria included in the City of Cape Town: Control of Undertakings that Sell Liquor to the Public By-Law, 2013.
- (b) Should complaints be received concerning noise and/or unruly behaviour of patrons, these complaints will be investigated and may result in the extended trading hours being withdrawn and will also be referred to the Western Cape Liquor Authority which may jeopardise the renewal of the liquor licence.
- (c) The applicant must ensure that no sale of liquor is made directly to or via a third party to unemployed and/or homeless persons occupying public open spaces in the vicinity of Cubana Tableview, Unit 1, 12 Beach Boulevard, Tableview, 7441.
- (d) This application is also subject to compliance with all relevant by-laws of the City of Cape Town.
- (e) This application will be valid for 12 months from the date of the decision subject to the possession of a valid liquor licence.
- (f) That this application is granted subject to the specific level of Lockdown Regulations applicable.
