Thereafter, the Subcouncil, IPAC and Council report submissions will follow. The SCM process for the disposal of the property will follow once the Council's inprinciple-approval-to-dispose is in place.

- The Chairperson stated that Line Departments should do the implementation by putting money aside for jobs under R30 000 in order for community based vendors to benefit. He stressed the fact more business need to register on the community based vendor's database as there are only a few registered in Ward 109. He said it won't work if there are a few registered.
- Mr Ligwa stated to complete the documentation and all the forms that need to be attached is very scary for the people and this prevents them from registering. Also when they are being given tenders they need to pay out of their pocket and will be reimbursed afterwards as this is also a blockage as they don't have funds available on hand.
- Mr Louw stated another scary thing is that people will have to go to Cape Town to register and they don't have money for travelling fare to go to the Civic to register. This also result in people not registering on the community based vendors and their mind set is that the City will supply everything when they tender for a job.
- The Chairperson will request the assistance of LED, Economic Development to give a workshop on registration, start up funding and guidance on how to look into the R30 000 projects.

 R37 000 has been spent on the project by procuring gym equipment.

Macassar Sportsfield - Upgrade

To construct an access road to the sportsfield.

Sydney Kuhn Civic Centre – Sound Equipment

Sound system has been delivered.

Upgrade Parks

Project completed at Marvin Park.

Paardevlei Project - Soil Remediation

 No expenditure will take place on this project for this financial year will only be spent in the next five years because of the development taking place around Paardevlei. Budget to be reallocated to other priorities. He said the funds should not leave Macassar it be spent in Ward 109.

Macassar BNG Housing

 A BNG Housing meeting was on the 12 February 2019 in Macassar. A site meeting was held on 18 January 2019 in Macassar for people who wished to tender and it will close on 26 February 2019. Thereafter the BAC will take place. The project is anticipated to start in July 2019.

CCTV Camera

· A camera was installed in Magdelina Gila Street but it was
