To inform the Sub council 24 of the public participation processes followed for designating a portion of an area in Stormhaven Park situated in Somerset West as a 'Dog-Off Leash area'.

### 5. EXECUTIVE SUMMARY

Stormhaven Park situated in Somerset West is currently utilized for general park activities, informal dog walking and invaded by street/ displaced people. In response to community request / concerns the Recreation and Parks Department proposed that a designated area be assigned in the park as a 'Dog-Off Leash area'.

The public were afforded a 31-day comment period commenced from 2 March 2020 and concluded on the 02 April 2020 to comment on the assigned proposed area.

Notice of the proposal in obtaining public comment were advertised in the Helderberg Gazette. Besides notification in the local newspaper communication / information were forwarded to organizations listed on the Sub council database. Posters were also visibility displayed at the Sub council 24 offices, libraries and the Khayelitsha and other administrative building. Interviews were conducted with the public at the park and living in the surroundings of the facility in question.

The Recreation and Parks acknowledges all comments and submissions received from the public; (parties affected and interested).

Stormhaven Park is to be reclassified and designated into a Dog Off Leash Park, and park users are urged to comply with the 2010 Animal Bylaw.
