3. PURPOSE

The purpose of this report is to consider the application for extension of liquor trading hours from 18:00 to 20:00 Monday to Saturday trading for off-consumption premises in terms of Section 6(5) A of the City of Cape Town: Control of Undertakings that Sell Liquor to the Public By-Law, 2013.

FOR DECISION BY

Subcouncil in terms of Delegation Part 24: 4(2)

Approve, refuse or vary applications for extension of trading days and hours on premises where liquor licenses have been granted.

4. EXECUTIVE SUMMARY

The City of Cape Town: Control of Undertakings that Sell Liquor to the Public By-Law. 2013 was promulgated on 17 January and coming into effect on 1 February 2014.

An application for extension of liquor trading hours in terms of Section 6 (5) A of the By-Law was submitted to the Health Directorate and circulated to the relevant departments for comment. The fully signed application, including all required comments was submitted to the Subcouncil Manager, and was then circulated to abutting neighbors, all organisations included on the Ward 27 database and Ward Committee members for comment.

Clause 9 of the By-Law requires that the City must, before approving an application for the extension of trading days and hours, reasonably and fairly consider further factors which must include, inter alia-

- (a) the validity of the liquor license;
- (b) where applicable the validity of a business license issued in terms of the Business Act of 1991 (Act No. 71 of 1991);
- (c) location category as per the schedule;
- (d) previous suspension, amendment or revocation of extended trading days and hours including previous records of complaints investigated and confirmed in respect of the last twelve months preceding a current application for extension;
- (e) the proximity of the licensed premises to surrounding residential zoned area, cultural, religious and educational facilities;
- (f) outcome of community consultation and the recommendation of the relevant ward;
- (g) the potential impact on the surrounding environment;
- (h) whether it is in public interest to approve and grant an extension of trading days or hours; or
- (i) a motivation from the applicant dealing with the impact of-
 - (i) the risks to and nuisances on the surrounding community
 - (ii) mitigation measures to assist the control of risks and nuisances; and
 - (iii) possible benefits of extended liquor trading hours and days on the surrounding community.

5. DISCUSSION/CONTENTS

5.1 Section 6 (5)A of the By-Law reads as follows:

6(1) Subject to subsection (5), (6) and (7) a licensee may upon payment of the required fee, submit a written application to the City to extend the liquor trading days and hours of licensed premises.

Pick 'n Pay Liquor (N1 City)

The Applicant was allowed to sell liquor until 20h00 in terms of its licence issued under the Liquor Act 27 of 1989.

The Western Cape Liquor Act was approved after widespread public participation and it is submitted that it reflects the will of the people of the Western Cape.

The Act provides for licence holders with off-consumption liquor licenses to apply for trading hours until 20h00.

It is submitted that the Control of Undertakings that Sell Liquor to the Public Bylaw reflects the will of the citizens of the City of Cape Town.

This includes allowing responsible licence holders to apply for extended trading hours until 20h00.

Due to their working hours a significant percentage of the applicant's customers find it very difficult to purchase liquor before 18h00 on weekdays.

The extension of trading hours until 20h00 will allow them to do so (as they had been able to do under the Liquor Act 27 of 1989).

THE PROXIMITY OF LICENSED PREMISES TO SURROUNDING RESIDENTIAL ZONED AREA, CULTURE, RELIGIOUS AND EDUCATIONAL FACILITIES

- The nearest residential area is: Vasco, approximately 1 km from the premises
- The nearest religious facility is: His People Church, approximately 600 meters from the premises
- The nearest educational facility is: Fairburn College, approximately 1.5 km from the premises

The manner in which the business is carried on under the current trading hours does not prejudice the residents of a residential area or the proceedings in cultural, religious or educational facilities and it is submitted that there is no reason why an extension to 20h00 will change this situation.


