5. EXECUTIVE SUMMARY

 - iii) In the event of subcouncil delegation 7 (2) which authorises the subcouncil to grant permission for the use of public open spaces, public squares and similar places within the Subcouncil's area of jurisdiction, for any local events, and which due to time constraints cannot be submitted to one of the scheduled subcouncil meetings for consideration, the subcouncil manager or acting subcouncil manager, in consultation with the chairperson and affected ward councillor, be authorised to deal with and finalise such matter;
- (b) A report **BE SUBMITTED** to the ensuing subcouncil meeting to report on the exercising of such delegations;
- (c) A report **BE SUBMITTED** quarterly to Council in terms of all delegations exercised by the subcouncil during the reporting period.

The report details the decisions the Subcouncil Manager has taken, in terms of delegation 7 (2) in conjunction with the Subcouncil Chairperson and affected Ward Councillor.
