3. PURPOSE

To decide on an application for the renewal of extension of liquor trading hours in terms of Section 6 of the City of Cape Town: Control of Undertakings that Sell Liquor to the Public By-Law 2013.

4. FOR DECISION BY

Subcouncil in terms of Delegation Part 24.4 (2)

To approve, refuse or vary applications for extension of trading hours on premises where liquor licences have been granted in terms of section 2 of the By-Law: Control of Undertakings that Sell Liquor to the Public 2013.

5. EXECUTIVE SUMMARY

An application for the renewal of extension of liquor trading hours in terms of Section 6 of the City of Cape Town: Control of Undertakings that Sell Liquor to the Public By-Law 2013 was submitted to the Health Directorate and circulated to the relevant departments for comment. The fully signed application, including all required comments, was submitted to the Subcouncil 6 Manager, and was then circulated to all Interested and Affected Parties for comment.

6. DISCUSSION

- 6.1 Subject to subsection (5), (6) and (7) of the By-Law a licensee may upon payment of the required fee, submit a written application to the City to extend the liquor trading days and hours of licensed premises.
- 6.2 The City may approve, amend or refuse an application for an extension of liquor trading days and hours for both on and off consumption premises.
- 6.3 An application for the extension of trading days and hours is not automatically renewable and
 - (a) must be submitted to the City for consideration on an annual basis; and
 - (b) may be approved by the City, subject to the imposition of conditions for extended liquor trading days and hours.
- 6.4 The following application for the renewal of extension of liquor trading hours in Terms of Section 6 of the City of Cape Town: Control of Undertakings that Sell Liquor to the Public By-Law 2013 has been received by the Subcouncil:

The application is not supported by the Land Use Management Department.

Upon further investigation, it was established that the liquor shop has been in existence before the City of Cape Town Integrated Zoning Scheme came into effect in November 2013. The liquor shop therefore established in terms of rights under the former Bellville Zoning Scheme that did not address sale of liquor as a separate use and it was regarded as a shop being a permitted use in terms of the old Local Business zoning of the property. The current liquor shop is therefore seen as a legal non-conforming use right and the liquor licence application can therefore be supported. (See Annexure C)

7. RECOMMENDATION



Pick 'n Pay Liquor (Boston)

The Applicant was allowed to sell liquor until 20h00 in terms of its licence issued under the Liquor Act 27 of 1989.

The Western Cape Liquor Act was approved after widespread public participation and it is submitted that it reflects the will of the people of the Western Cape.

The Act provides for licence holders with off-consumption liquor licenses to apply for trading hours until 20h00.

It is submitted that the Control of Undertakings that Sell Liquor to the Public Bylaw reflects the will of the citizens of the City of Cape Town.

This includes allowing responsible licence holders to apply for extended trading hours until 20h00.

Due to their working hours a significant percentage of the applicant's customers find it very difficult to purchase liquor before 18h00 on weekdays.

The extension of trading hours until 20h00 will allow them to do so (as they had been able to do under the Liquor Act 27 of 1989).

THE PROXIMITY OF LICENSED PREMISES TO SURROUNDING RESIDENTIAL ZONED AREA, CULTURE, RELIGIOUS AND EDUCATIONAL FACILITIES

- The nearest residential area is: Boston
- The nearest religious facility is: Vredelust Congregation situated 87 13th Avenue, Boston
- The nearest educational facility is: Boston Primary School situated in Lincoln Street, Totius Primary School situated in Boston Street and DF Malan High School situated in Alexandra street.

The manner in which the business is carried on under the current trading hours does not prejudice the residents of a residential area or the proceedings in cultural, religious or educational facilities and it is submitted that there is no reason why an extension to 20h00 will change this situation.

THE POTENTIAL IMPACT ON THE SURROUNDING ENVIRONMENT

The current activities of the applicant do not have any negative impact on the surrounding environment and it is submitted there is no reason why an extension to 20h00 will change this situation.

THE RISKS TO AND NUISANCES ON THE SURROUNDING COMMUNITY

The current activities of the applicant do not pose a risk or nuisance to the surrounding community and it is submitted there is no reason why an extension to 20h00 will change this situation.





Upon further investigation, it was established that the liquor shop has been in existence before the City of Cape Town Integrated Zoning Scheme came into effect in November 2013. The liquor shop therefore established in terms of rights under the former Bellville Zoning Scheme that did not address sale of liquor as a separate use and it was regarded as a shop being a permitted use in terms of the old Local Business zoning of the property. The current liquor shop is therefore seen as a legal non-conforming use right and the liquor licence application can therefore be supported.
