5. EXECUTIVE SUMMARY

As part of the City of Cape Town's 5 year integrated Human Settlements Plan, the City has identified land for development of low-income housing in Delft. All development and funding approvals are in place and the project has received support from various City, Provincial and community role players. The project has been under construction since August 2012 in various phases.

7. DISCUSSION/CONTENTS

The Delft The Hague Phase 1 housing project funding application for the construction of 1012 houses was approved by the Provincial Human Settlement department in 2014. Moreteng Investments was appointed as the building contractor through a competitive tendering process which saw them commence work on site in September 2015. AECOM are the appointed professional consultants supervising the work on behalf of the City of Cape Town. The estimated completion date for this phase as per the contract is June 2018.

This phase of the project has seen various unforeseen delays which have hampered the progress of the project ranging from non-compliances to Health & Safety regulations, poor contractor cash-flow and material supply issues, to work-stoppages resulting from disputes between the main contractor Moreteng and local sub-contractors. Moreteng has removed certain local sub-contractors due to poor quality of works they were producing. Because quality cannot be compromised the City supported Moreteng in this decision but Moreteng has not been able to increase their own capacity and increase productivity.

The contractor to date has handed over 120 units to beneficiaries thus far, which is unacceptable. The contractor's construction programme is currently behind by 1 year, according to their original construction programme. This is unacceptable performance by the contractor.

As a result of the on-going non-performance and quality issues the City has issued the contractor with a notice of termination letter. It is expected that the contractor will complete all units currently in progress before moving off site on 30 September 2017. It envisaged that a further 160 units will be delivered by the contractor before they vacate the site. An alternative arrangement to complete the balance of units left in the Moreteng contract is currently in progress.

To date all 1012 beneficiaries have been approved for the Delft The Hague Phase 1 project. 467 beneficiaries have been approved for the Delft The Hague Phase 2 & Eindhoven project, which will commence before the end of this year. 755 beneficiaries have not responded to letters and SMS's inviting them to come and apply to the project and the matter has been referred to Project Steering Committee (PSC) meeting of 12 September 2017 to decide what should be done regarding further efforts to contact the 755 beneficiaries.
