Mr Vernon Moonsamy delivered an informative presentation on the process of updating the spatial development framework for the eight planning districts with the latest information about the state of the population, their employment levels and income; the state of the urban and natural environment and heritage; state of development; the supply of and demand for housing; local economy; property market; and current services and infrastructure in these districts.

All of this information is included in a Baseline and Analysis Report (BaAR) for each district, inclusive of the challenges, needs and opportunities on a local planning level.

The review of the district SDFs will be based on the BaARs for the respective districts. It is therefore crucial for community leaders and stakeholders in each district to participate in this process.

It is also important for the City and residents to consider the current situation in each planning district before we embark on a review of proposals and guidelines of the respective district SDFs.

The district SDFs will be finalised during further rounds of public participation in 2020/2021. These will deal with the concepts and the final proposals.

Once approved by the City Council, the district SDFs will guide future decisions about developments, land uses, and interventions to create integrated and inclusive communities across Cape Town.

Following the presentation, the ward committee members were invited to submit their input on Opportunities, Issues and Ideas.

A copy of the presentation is attached to the minutes.

The additional input from the ward committee members will be used to supplement the BaAR report and will also be included as an annexure in the final District Planning Document.

It was noted that the due date for comments on the draft Baseline and Analysis Report (BaAR) is 31 January 2020.

WARD COMMITTEE MEETING - 3 DECEMBER 2019 FINAL FOR THE YEAR

This is the last meeting of the year. I would like to thank each one of you for the important role you play in the Community. Even though you might not attend all the ward committee meetings and given the short time frame of these meetings, I am always available at any time to discuss matters of concern and together with you try and get a solution for whatever the problem is. Things do happen very slowly in this environment and there are so many restraints, but because of active and involved residents like yourself, things do and will happen for the best.

CHALLENGES IN WARD 1

- RICHWOOD WOODLANDS DRIVE Safety and Security issue/crime does happen across this area along the N7. There were also serious unrests this year putting residents of Richwood safety at risk
 - a. I had a meeting with the Mayor and will try yet again motivate that a fence be erected on this land and did get a quote. This is easier said than done but we need to pursue this. It is very important to note that if and whatever happens we are not going to prevent pedestrians crossing into Richwood until acceptable alternatives are in place. So if a fence does happen, it will have a turn style gate for pedestrians to use enabling Richwood security to focus their attention The proposed gate will be where a CCTV camera will be placed linked to the control room for the protection of residents and pedestrians alike

2. TRAFFIC CALMING NEXT TO PANORAMA AND MONTE VISTA PRIMARY SCHOOLS

a. Word has already been done at Monte Vista Primary School and new signage for Panorama School will happen in this financial year

3. TRAFFIC PROBLEMS

- a. Speeding on numerous roads throughout the ward
 - i. Montague Road
 - ii. Monte Vista Boulevard
 - iii. Uys Krige
 - iv. Rothshcild Boulevard
 - v. Gert Van Rooyen
 - vi. Giel Basson
 - vii. Plattekloof/Panorama/Plattekloof
 - viii. Burgundy Drive Burgundy Trucks
 - ix. Some roads in Richwood

b. <u>Taxis are becoming a huge problem in the Pattekloof/Parnorama area</u>

- i. Olienhout/Plattekloof/Hennie Winterbach
 - This has been referred to Network Management and we need to put pressure that something be done/not just by Traffic Services but get permanent solutions

c. Potholes

- Many bad potholes throughout the ward issues with quality of work which does worsen due to rain and again problem with SCM
- ii. We managed to get the Pothole Campaign in ward 1. Mayor Dan Plato personally assisted with the repair of 2 potholes drawing attention to this issue.
- iii. Request to please never stop reporting potholes
 Residents must please keep logging service requests

4. SERVICE DELIVERY

- a. <u>SCM causing huge problems/legality</u> causing us all to not get the quality of service delivery we need and putting immense pressure on our officials on the ground
 - i. City Parks (Tree Trimming, mowing, moles, ect)
 - ii. Reinstatement (Water related)
 - Please note that I did bring a motion to Sub Council 3
 about this. It is now a MRA and we will put constant
 pressure on the Dept of Water and Sanitation and Roads
 and Stormwater to resolve the problem
- 5. SEWAGE SYSTEM IN PANORAMA regular work being done to eradicate/reduce the problem of sewer spills
 - a. Budget required to have sewer pipes replaced over time
 - b. Many water pipes have already been upgraded in the area
 - This is also where many reinstatement complaints come from – pipes replaced but reinstatement of the road/pavements not happening fast enough (SCM/tenders)
- 6. ANNANDALE HOUSING DEVELOPMENT (MIXED DEVELOPMENT) not a problem but has caused some concern for Richwood/Burgundy and the new De Zicht Development:
 - a. We have had a few meetings with the professional team, Duke Gumede and Ryan Thomas of Housing Development. Like your RRRA and RNW are always invited. I also personally went to discuss this with the Mayor. He was very kind (and as usual) available and did a Walkabout on the land on 19/11/2019.

- b. Important to note that an Environmental Impact Study needs to be done first and this will take about 3 years.
- c. Also whatever happens on this land will and may not negatively impact on neighboring developments/suburbs. Any development Must add value to the area.
- d. I have drawn attention and insisted on all these meetings to ensure that whatever happens in the future, Richwood, Burgundy and De Zicht are taken into consideration and the design will be of such a nature that residents of the new Annandale development will not be forced to cross roads to get to places of work/transport and that this all be accommodated in any plans/designs from the start
- 7. OF ALL OUR PARKS the Park on the C/o Olienhout Avenue and Plattekloof Road in Plattekloof is giving us the most problems- LE have regular patrols and interventions. But this is not resolving the problem

SOME GREAT MILESTONES OF THE PAST MONTHS:

- 1) RECYCLING commenced at the start of October 2019 in a large part of ward 1 the whole of ward 1 should be on board as early as April 2020
 - a. Despite some complaints and hitches, things have gone surprisingly well
 - Waste Plan are the contractors and if any problems are experienced Please contact them directly or log a service request
- 2) THE CAMOENS PARK LEGACY PATHWAY PROJECT was completed with ward allocation and 21 pathway lights were put up by the Electricity Department because of engagement
 - a. This has had such a positive response and created a safe space where people come for exercise and fun with their family, children and dogs (Which we frustratingly keep trying to get dog owners to keep on a lead)
- 4 NEW OUTSIDE GYMS have recently been installed in Ward 1 and 2 have been upgraded with 2019/2020 ward allocation
 - a. NEW:
 - 1. Alk Van Zyl Park in Panorama
 - 2. Malmesbury/La Provence Road Welgelegen
 - 3. Richwood Community Hall
 - 4. Olienhout Park/Duck Pond/erf 20908 Plattekloof
 - b. UPGRADES:
 - 1. Gym on Camoens Park
 - 2. Gym on Malmesbury Road opposite Fuel Station
 - c. UPGRADES IN THE FORM OF PARK EQUIPMENT AND PLAY EQUIPMENT with ward 2019/2020 Ward Allocation ect for many parks in Ward 1 are in the pipeline

- Two pieces of Play equipment for Disabled on a corner of the Camoens Park – Bench already installed. This should happen as early as January 2020
- d. Closure of two alleys in Plattekloof 1 Tecoma Close and between AP Burger and Uys Krige (Tecoma will remain open with a turnstyle gate)
- 4) LPR AND CAMERA CONTRIBUTION HAS INCREASED TO 9 CAMERAS since 2016 R90000 this financial year Ward Allocation 2019/2020:
 - 1. R50000 of last year and R30000 of this year's ward allocation will go to a Camera on Woodlands Drive Richwood communication already in place with a Richwood resident on whose property an installation will be done. Just waiting for "high site" to be done by City of Cape Town Law Enforcement.
 - R30000 each for PWP LPR and Monte Vista LPR is available for 2019/2020 fin year – so please make contact with Chris Moller of LAW Enforcement to discuss.
 There are 76 LPR cameras in Sub Council 3 (Wards 1, 4,5,70,107 and 113)
 - 3. There were 11 285 807 reads for the month of Oct 2019 with an average of 140 184 per day. In Oct 2019 34 arrest were made because of LPR cameras. This consisted in the arrest of suspects involved in robberies and housebreaking. Metro Police Depart and Law Enforcement Services were involved in arresting suspects and providing support with a number of arrests
 - 4. Thanks also to Safety and Security Companies for involvement and the LPR Group
- 5. EQUIPMENT TO OUR 3 NHW's further contributions will be made

- 6. In the RICHWOOD COMMUNITY HALL equipment to the value of R50,000 was paid for with Ward Allocation
 - 1. Table Tennis table
 - 2. Snooker table
 - 3. Karate mats

This will add value to programs offered in this hall for the community

- 7. We were very fortunate to get MURP FUNDING of R400k this financial year This is above the R1M ward allocation and only for Operational expenditure
 - a. R150000 was allocated to Chief Johannes Van Schalkwyk and his team at LAW Enforcement for LE operations in Ward 1
 - After hours, Loverslane, Fynbos Close, Olienhout Close
 Plattekloof ect
 - b. R250,000 was allocated for maintenance in Ward 1
 - i. I visited almost all the parks, got input from residents and ward committee members and provided a substantial list of maintenance work that needs to be done on Parks in Ward 1
 - Due to SCM Contracts we are not sure what will be done but I have been given the assurance that the funds will be spent on maintenance
 - a. Pathways, Ranch fencing painting, equipment ect

8. ROADS:

- a. Giel Basson has almost been completed TDA cannot give a specific date of the opening this new road. A few snags need to be addressed and I am hopeful that this will happen in the new year
- b. N7 is currently being upgraded in the area along Richwood Underway upgraded/'fencing" along Du Noon which should give some relief to the pedestrians crossing over the N7 putting their lives and those of motorists in danger
- c. Tygerberg Valley Road in process of being upgraded and good progress is being made
- d. TDA NMT Project of which Monte Vista is part of has made good progress.
- e. Resurfacing of Roads
 - i. A few have been done in Monte Vista
 - ii. Those earmarked in rest of Ward 1 will be done before the end of the fin year in June 2020.
 - iii. Please give a wish list of what roads need to be resurfaced.

 Due to immense cost not everything can be done overnight
- 9. The DISABLED LOOKOUT IN THE TYGERBERG NATURE RESERVE has been completed with the contribution of Ward Allocation of Ward 1 and Ward 70 and this has been very positively received. It is so important to include Disabled people and I do think that we are improving the awareness of disabled people and making life easier for them and make them feel just as part of the community
- OPERATIONS 2 monthly happen from Monte Vista in Ward 1 to surrounding areas – With Solid Waste, Law Enforcement, DPU, Social Development, PRASA, Correctional Services ect
 - a. The person who drives these operation is undoubtedly Riana De Wet, secretary of the Monte Vista Ratepayers. I want to again thank her, also on our behalf, for her persistence and the

wonderful relationships she has created. She has achieved the impossible and the difference is clear. We have to say thanks to all involved. Thanks also to Paul Kruger who hardly ever misses being part of any of these operations and Riana De Wet for never giving up

- b. 2nd weekly operations also happen in ward 1 with LE, Solid Waste, Social Development.
 - i. These operations do help to keep our ward neat and tidy.

- ii. Noise, health issues, indecent public behaviour, etc.Students of Northlink college regularly drink here
 - 1. Perhaps we should consider to try and resolve this problem with the 2020/2021 Ward Allocation budget?
 - a. Consider selling the land for development
 - b. or make it a dog park (With ward allocation)
- iii. Please share ideas with me for the 2020/2021 financial year
 - a. LPR Cameras
 - b. Safety and Security
 - c. Speed calming Baronetcy application has been approved
