## 5. EXECUTIVE SUMMARY

Grant-in-Aid are allocations of funds, from the Subcouncil approved operating budget to qualifying organisations.

These allocations provide organisations with funds for carrying out projects which assist the City in exercising its legislative obligations which include any additional competencies that may be assigned to the City by National of Provincial Government by means of an Implementation Protocol.

A globular amount was allocated on the Ward Allocation Budget in respect of the 2018/2019 financial year for Ward 6 only. R20 000 was allocated to Sinceduluntu Feeding Scheme operating in Ward 6 area in respect of the following:

• The establiment of a soup kitchen to the unprevillage community members and hungry people.

The once-off EFT payment in the amount of R20 000 was made to the organisation on 28 June 2019.

The organization must submit monthly reports reflecting the expenditure for the particular month and the Subcouncil must be informed of such expenditure on a monthly basis.
