#### 2. PURPOSE

To report on progress made with the Gugulethu Infill Housing Project until the end of February 2019.

#### 3. FOR DECISION BY

#### 4. EXECUTIVE SUMMARY

Development is taking place on two separate erven, Erf 2849 (MauMau) and Erf 8448. Progress on these sites is described separately for each erf below.

## 1. Project Progress on Erf 2849 Gugulethu

- ✓ Contractors on site are Siqu Group and Khethwayo construction for the
  construction of 431 units with their related electrical infrastructure and
  sidewalks.
- ✓ Top structure construction commenced on 18 June 2018 on erf 2849 with 276 houses under construction at various stages. Project completion is estimated to be February 2020.

Making progress possible. Together.

- ✓ The installation of the bulk electrification and sidewalks is on track to commence shortly.
- ✓ The City's watermeter contractor is due to commence with the installation of the water devices by the end of March 2019.
- ✓ Practical completion for the first 50 units due at the end of April 2019.
- ✓ Contractors are making use of the Sub Council Database for both local enterprise and local labourers.
- At least 5 subcontractors have been appointed under Khethwayo and 2 under Siqu.
- ✓ Approximately 25 local labour opportunities have been created by Khethwayo and 19 by Siqu.

# 2. Project Progress on Erf 8448 Gugulethu

- Contractors are being appointed via the Provincial Department of Human Settlements' framework of contractors. Work packages for these appointments have been finalized and the tender evaluation has been completed. Three contractors have been appointed.
- √ 570 houses will be built for Gugulethu backyarders and completion is
  estimated to be mid-2021.
- ✓ The advertisement for three Community Liaison Officers (CLO) for the three
  different contractors will run on 21 March 2019. The closing date for
  applications is 4 April 2019.

#### 3. Beneficiary Administration Process

- Officials are now manually verifying approved beneficiaries per ward (i.e. on a map). Progress is hampered by changed street names from NYs to names.
- Out of 1080 processed applications for both sites, 910 applications have been approved.
- √ 269 applicants have been approved for Nyanga and 131 for New Cross
  Roads, they will all be allocated on erf 2849.
- √ 510 applicants have been approved for Gugulethu; to be allocated on erf 8448.

✓ The allocations are only for backyarders and exclude existing and recently.

upgraded informal settlement areas and hostels.

√ The project makes a 5% provision for special needs cases. i.e. elderly and physically challenged, and 10% for residents not on the database with valid

proof of long stay in the target areas.

4. General

✓ The City's Human Settlement Implementation Department, in conjunction with

the Provincial Department of Human Settlements is assessing the provision of

additional security for both sides.

✓ A series of public meetings will be held on 5, 6 and 7 March 2019 to announce

the commencement of work on Erf 8448 Gugulethu. A sod turning ceremony

for this site will also be arranged for March 2019 (date to be confirmed).


