3 PURPOSE

To request Subcouncil 8 to endorse the amendment of the sectors represented on the Ward Committee of Ward 86.

4 FOR DECISION BY

Subcouncil – The Subcouncil, in terms of clause 3.2 of the Rules for the Election and Establishment of Ward Committees for the City of Cape Town, adopted by Council on 26 October 2016, vide C 19A/10/16, has the authority to establish and determine the composition of ward committees. This determination is to be preceded by a recommendation from the respective ward councilors.

5 EXECUTIVE SUMMARY

At its meeting held on 15 November 2016 (**08SUB 09/11/16**) Subcouncil 8 inter alia resolved that the following ward committees be established within the Subcouncil area.

All the interest groups (organisations) registered on the Organisations Database of Subcouncil 8 by 18 November 2016 and registered under the relevant sectors determined by the Subcouncil (as reflected in the schedule above), were invited to nominate of its members to serve on the relevant ward committees.

Due to poor interest of the interest groups (organisations) invited, few nominations were received and Ward 86 Ward Committee were left with a vacancy.

Furthermore, it was recommended at Ward Committee meeting held, Wednesday, 7 October 2020 that the seat of Business Sector be amended to Sports Sector.

6 RECOMMENDATIONS

That the recommendation from the Ward Councillor, namely that the sectors on the ward committee of ward 86 be amended to include a seat for the Sports Sector and be endorsed by Subcouncil 8.
