## **Draft Integrated Waste Management Policy**

The City of Cape Town invites residents to comment on the Draft Integrated Waste Management Policy.

- The City wishes to articulate bold measures to achieve the policy objectives, protect the environment, and offer progressive, sustainable options for integrated waste management given the City's burgeoning population and ongoing increase in the volumes of waste generated.
- There is a need to divert waste from landfill so as to ensure that landfill airspace is not depleted sooner than necessary. The City, therefore, recognizes its responsibilities to reduce and minimize waste, and impacts on resources and the environment through this policy.
- The City is required to regulate the interventions, mechanisms and technologies applied within the city's boundaries to minimize and manage waste minimisation in a sustainable, effective, equitable and efficient manner that will minimize social, health, environmental and economic impacts as far is practically possible.

In terms of section 17 of the Local Government: Municipal Systems Act, Act 32 of 2000, the public and interested parties or groups given the opportunity to submit comments, recommendations or input to the municipality from February 2020 to March 2020.
