**95WC 05/10/19      MATTERS ARISING FROM THE MINUTES**

- Mbongeni Tikipeni referred to page five, **95WC 07/08/19, Ward Allocation Project Proposals for 20/21 FY**, the 4<sup>th</sup> and 5<sup>th</sup> bullet points where it reads ECD support R150 000 and Sport

Programmes R100 000 and indicated that the amount for ECD was R100 000 and Sport Programmes was R150 000 that was agreed upon.

- Goodman Rorwana responded that when the additional amount of R150 000 was approved by Council in the January 2019 Adjustment Budget they wanted to allocate funding towards the ECD support but the proposal was cancelled and allocated it towards the NHW Equipment project. It was then agreed that in the 20/21 FY they will allocate the R150 000 towards the ECD Support. Therefore, the information reflected on the minutes is correct.

#### **95WC 06/10/19      PROGRESSIVE CAPITAL EXPENDITURE: AUGUST 2019**

Goodman Rorwana went through the PCER and highlighted on the following projects:

##### **Construction of Park - Zweliitsha**

- This is the rollover funds and the Department has ordered the rubber tiles for the Zwelitsha Park.

##### **Upgrade Parks – Ward 95**

- The fencing bill of quantities has been completed, awaiting site-meeting date with the contractor and thereafter orders will be placed.

##### **Public Transport Facility: Makhaza Bus Facility**

- This project is taking place at Chris Hani Station at the open space where the kids are playing soccer, will be converted into a bus facility, and will have a MyCiti interchange station. The amount of R350 000 that reflects on the PCER is for professional services to do the conceptual designs not for the implementation of the project.

##### **Sports Day Event**

- R39 000 already committed and a committee established with the Recreation & Parks Department and the Ward Cllr and that work is in progress around the tournament.

##### **Capacity Building: Seniors**

- A meeting was held with the officials of Social Development and

the agreement was the Cllr and the leadership was going to discuss the menu, presents and programme for the day but up until now, he has not received a response yet.

- Cllr responded that he did email the information to the Subcouncil Manager; the gifts they require are 200 fleecy blankets. The event will take place on 29 November 2019. The programme will be drafted by Social Development Department and the Cllr to bring groups who will do a few performances as part of the entertainment to be included in the programme.

#### **Heritage Day Event**

- A second follow-up was arranged but none of the members was present.
- The Chairperson responded that he and the leadership had a meeting yesterday, 2 October 2019 regarding the heritage day event and they agreed that they would sit with the department next week in order to finalize the programme.

#### **PROGRESS REPORT: C3 NOTIFICATION**

- Goodman Rorwana stated that most of the C3's are water related complaints and this is a huge challenge. He said the sms option is the most effective tool that assists customers with complaints that was lodged.
- Mbongeni Tikipeni stated that they had a meeting with Mr Mati of Water and Sanitation Department where they reported many

issues including the broken and blocked Mtshengu toilets but nothing has been done. Yet Mr Mangaliso promised them that he would tend to the complaints.

- Duduzile Nenembe stated that most of these toilets are blocked as well as the drains. It gets fixed and then the problem occurs the next day.
- Goodman Rorwana responded that the whole problem is around the water supply pressure is very low in that area and not enough and the blockage problems will always occur. Until they fix the water supply pressure will the blocking of drains be resolved.
- Cllr Dasa raised concern that they lodged complaints about potholes but does not see it reflected in the report.
- Goodman Rorwana responded that Cllr Dasa need to send him the pictures and he will forward it to the Line Department.

#### **RESOLVED**

- That a meeting be arranged with Mr Mati, the Depot, Ward Cllr and Ward Committee members regarding Enkanini.

#### **95WC 08/10/19      MATTERS RECEIVING ATTENTION**

- Goodman Rorwana reported that the erf 1322 is earmarked for the recycling project next to the power station in the next 2 – 3 years. He said Khayelitsha needs disposal sites for job creation by converting waste into money. What now happened people invaded the piece of land and this defeats the purpose of what the intention was of this project. He raised concern that Ward 95 will lose this project due to land invasions.
- The Chairperson stated that there is a big challenge and he is not sure whether Law Enforcement is incompetent but they know that people are invading the land and do nothing, they first want to receive a call from them as Cllrs before they act. He says corruption is taking place, people are paying Law Enforcement officials, and they are selling the land. In Zwelitsha, the S Section where people also invaded and anti-Land Invasion demolished the shacks but left the other people that invaded the land. He requested a meeting with the anti-Land Invasion Department.

- Goodman Rorwana responded that this issue is a bit tricky because once people start invading the land it becomes the problem of Informal Settlements and then the Department need to look at providing services for the people. If Land Invasion has failed then it becomes the burden of another Department. At the stage it is happening across the City where people invade then Land Invasion demolish the shacks then it happens somewhere else and this cycle continues. He stated if there are allegations of corruption then people need to report these incidence to the City of Cape Town and provide evidence for this to be investigated if it is a city official with a case number.
  - The Ward Committee members stated that Law Enforcement is failing them dismally because they do nothing when you report these matters of corruption.
  - Cllr Dasa stated that if they can bring these matters to him as he sits on the Safety and Security Portfolio Committee

- Cllr Dasa to raise this issue at the Safety and Security Portfolio Committee and report back to the next Ward Committee meeting.
