Sub-council news

The Asanda Village Wetland Parkland

The City of Cape Town has undertaken to upgrade the wetland and public open space situated between the N2 and Asanda Village. The intention of the upgrade is to transform the wetland and open space into a new wetland parkland. A community workshop was hosted in 2015 to inform the concept design of the Asanda Village Wetland Parkland.

In terms of section 17 of the Local Government: Municipal Systems Act, Act 32 of 2000, the public and interested and affected parties may submit comments, recommendations or input to the municipality before 3 November 2020.

On 6 October 2020 a Subcouncil Activity Day skype meeting took place with the Executive Director Transport and Acting Director: Roads Infrastructure & Management, Director: Urban Management, SC Chairperson, SC Councillors, SC Manager and officials to discuss the way forward on the Roads Infrastructure & Management within the Subcouncil wards.

Note that the matter was resolved with roads which was identified by the Ward Councillor's which needed urgent attention namely in areas such as Lwandle, Asanda Village and Nomzamo. The City is frantically working on major backlogs due to COVID-19 lockdown.

On 15 October 2020 a meeting with the Executive Mayor Dan Plato, Executive Mayco members Ald. Felicity Purchase (Transport), Cllr Zaheed Badroodien (Community Services & Heal) and Ald. J.P Smith (Safety & Security) were held with the Gordon's Bay Ratepayers Association on a number of issues regarding the status of Gordon's Bay. Many of the issues raised and the lack of services rendered was due to the National lockdown and working with minimal staff it was difficult for the City to tend to many if not all the issues raised for the past 6 months.

Our Sub-council has undertaken the task to assist and resolve the matters at hand with the various Mayco Portfolios.

Note that each month the Executive Mayor, Ald. Dan Plato have service delivery issue discussions in conjunction with the City Manager/Director and Subcouncils to ensure that line departments get to deliver the services to our residents.

On 9 October 2020 a ceremony for Hand-over of Bravery certificates was held at the Strand Fire Station to a young boy named Domino Smith who has lost both his parents due to their house which burnt down and even lost their dog.

Hotspot Weekly Report: 19 - 23 October 2020

Law Enforcement Department:

All Covid-19 operations were halted due to the land invasions. Law Enforcement staff is still busy with the Land Invasions across the City. Until such time when the threat is stabilized, they will remain busy with that task.

Traffic Department:

Assisting with Anti Land Invasion operations

Request is made for all Councillors to immediately report land invasion as it was reported that land invasion is taking place again.

Health

Awareness, monitoring and water quality were done at Shoprite Broadlands Centre Strand. String bags, crayons, soaps, pamphlets and posters were distributed to approximately 120 residents. A need for Law enforcement foot patrols amongst informal traders at entrance are needed as there is a low adherence to Covid-19 principles and food safety.

Health promotion and Covid-19 awareness were hosted at Rusthof LSN school, Strand and string bags, soaps, pamphlets, posters were distributed to approximately 65 learners. Awareness on Risk behaviour regarding substance abuse were made aware amongst learners.

<u>Health Department</u>: 8 out of 10 schools reached with covid-19 health promotion awareness btw. Aug. - Oct. 2020 in Lwandle/ Nomzamo areas, 80% coverage.

Waggebietjie informal settlement with 120 persons reached Monday 05 Oct. 2020 CBT outreach: Covid-19 screening, chronic diseases testing, diarrhoea, HIV testing, health promotion & child immunisation. Thu. 08 Oct. 2020 it had been noted Ikhwezi clinic have a social distancing problem with 70 persons reached and disposable masks handed to the community.

City's Housing Needs Register

The City of Cape Town's Housing Needs Register is the first step for qualifying residents to be considered for a variety of affordable housing opportunities across the metro on a first-come, first served basis taking in consideration age and special needs

Qualifying beneficiaries are placed on the Register and when opportunities become available, beneficiaries are allocated opportunities in accordance with the Allocation Policy. If people are being asked to pay for a place on the Register, or a plot of land that belongs to the City, it is illegal and a scam.

The City encourages interested residents to register on the Housing Needs Register online or visit the nearest housing office.

Once residents have successfully registered, it is important to check and keep personal details updated when necessary. This is important so that the City may contact successful applicants to inform them about any available housing opportunities.

City reminds residents about opportunity to extend building plan applications

Approved building plans are valid for one year. However, residents can apply for an extension before the validity of the building plan has lapsed. Such an extension will also be dependent on all other prerequisites as per the due process. These include the validity of other applicable clearances or approvals relating to the original approval, such as land use departures, etc.

City commemorates World Homeless Day

World Homeless Day is celebrated annually on 10 October and aims to draw attention to the needs of people living on the street and provides opportunities for communities to get involved in responding to homelessness.

This year, the City engaged the street people sector, including representatives of the street people community to agree on a model which will speak to improved cooperation between the City, NGOs, CIDs, shelters as well as representatives of the street people community.

The purposes of World Homeless Day are to draw attention to homeless people's needs locally and provide

opportunities for the community to get involved in responding to homelessness.

Swimming pools set to open with different strokes

The Recreation and Parks Department has opened 14 of the 20 municipal swimming pools on Friday, 16 October 2020 but to ensure adherence to the regulations under Alert Level 1 of the National Disaster Management Act, it will not be business as usual. Delays have been experienced in opening some swimming pools due to unforeseen operational challenges.

Patrons are requested to familiarise themselves with the regulations and limitations before visiting the facilities.

The number of patrons allowed at open swimming pools has been reduced by 50% of each pool's capacity, therefore if the maximum capacity of a pool is 500 patrons, only 250 will be allowed into the facility.

Screening will be done on entry and persons with a temperature reading of over 38 degrees Celsius will not be permitted to enter the facility.

City encourages employers to prioritise mental health of staff

This Mental Health Awareness Month, the City would like to encourage employers to look at ways to prioritise the mental health of employees. Developing and actively promoting wellness programmes is key to ensuring that staff are aware of the help that is available to them. The City is especially focused on raising awareness of various mental health illnesses and the stigmas attached.

The City ensures a supportive environment by providing workshops specific to creating awareness of mental health illnesses and recommended coping mechanisms.

COVID-19 and lockdown regulations have challenged mental health in many different ways and encourage employers should be on the lookout for mental health issues amongst staff.

Cllr Mfecane commended Cllr Punt for his input with reference to the Wetlands project and thanked him for his assistance in making the project a success.

Cllr Punt responded as follows: That the Wetlands project is a good example of how good the Subcouncil can work together in making something a success. He further advised that he was not the only Councillor involved and that Cllr Cerfontein and Cllr Madikane also assisted.

Cllr Mfecane further reported that people living on the streets still remain a big challenge and a lot of the residents from Strand area is complaining about it. He advised the meeting that he had a drive-by about in the area with some of the community members and advised the meeting that hot spots were identified. However, the biggest question remains what is Department Law Enforcement doing about the situation as according to the residents nothing is being done.

Cllr Cerfontein responded that Law Enforcement is aware of the problem and numerous attempts have been made to address by Departments Law Enforcement and SCECD however, the street people/vagrants refuse help and in view of the current COVID-19 court laws that is in place, nothing can be done to have them removed from their current places of stay.

Cllr Punt further stated, referring to street people, that it is still a big challenge due to so many people being unemployed and requested all to encourage the community to give responsibly in providing donations to recognised organisations rather than giving directly food or money to those living on the streets.

Cllr Madikane further advised the meeting that she wanted to commend the officials. Responsible for the dignity campaign, that they are doing a sterling job.
