- A tariff rental of R966,09 per annum, excluding VAT calculated at the rate applicable at the time of transaction be payable. Rates not applicable;
- b) The lease will endure for a period of ten years;
- The rental will be adjusted annually in terms of the rental tariff structure as approved by Council;
- d) The property may be used for sporting purposes only;
- e) Subject to such further conditions to be imposed by the Director: Property Management in terms of her delegated authority;
- f) Subject to compliance with any other statutory requirements;
- g) No compensation will be payable for any improvement made to the property;
- h) The property may only be utilized for Open Space purposes, as defined in the Development Management Scheme of the City of Cape Town for the entire duration of the lease.
