3 PURPOSE

To endorse the revision of sector and / or seat composition of the Ward Committees in order to fill the vacancies that exist.

4 FOR DECISION BY

The Subcouncil in terms of clause 3.2 of the Rules for the Election and Establishment of Ward Committees for the City of Cape Town, adopted by Council on 26 October 2016, *vide* C19A/10/16, has the authority to establish and determine the composition of Ward Committees.

5 EXECUTIVE SUMMARY

Council has opted for the institution of Ward Committees for its current term of Office. In terms of clause 3.2 of the Rules for the Election and Establishment of Ward Committees for the City of Cape Town, adopted by Council on 26 October 2016, *vide* C19A/10/16, the Subcouncil has the authority to establish and determine the composition of ward committees within its area.

This determination is to be preceded by a recommendation from the respective Ward Councillor.

The following seats became vacant:

- Youth on 17 May 2018 due to the resignation of the representative;
- Safety and Security on 30 May 2019 due to the dissolution of the organisation; and
- Education and Arts & Culture on 30 May 2019 due to non-compliance with the Rules.

As a result of the above the composition of the Ward Committee needs to be re-determined in line with organisations registered on the Community Organisations Database.

6. RECOMMENDATIONS

It is recommended that

(a) Having taken into consideration the proposal of the Ward Councillor, the composition of the Ward Committee for Ward 51 **BE AMENDED** as follows:

- (b) The Subcouncil **ENDORSES** the amendments to the composition of the Ward Committee.
- (c) The Subcouncil undertake the process for the election of Ward Committee Members, in the following sectors Arts & Culture, Safety & Security and Education.
- (d) Cognisance be taken of the organisations registered as interested groups.

7. DISCUSSION/CONTENTS

On 20 January 2017 the Office of the Speaker announced the appointment of Ward Committee Members for the new term of Office and Combined Inaugural Meetings were held for Wards 53, 55 and 56 on 6 February 2017.

Due to the volatile situation in Langa the election and establishment of Ward Committees for Ward 51 and Ward 52 only took place on 3 May 2017 with the Combined Inaugural Meeting taking place on 11 May 2017.

Some seats remained vacant after the first elections of Ward Committees held in May 2017. In terms of rule 9 of the Rules for the Election and Establishment of Ward Committees for the City of Cape Town; should a request be received from a Ward Councillor that the Subcouncil should add or subtract a sector to be represented on a specific Ward Committee, the Subcouncil Manager in consultation with the Subcouncil Chairperson must determine the date on which the Subcouncil shall consider the request.

At the Subcouncil Activity Day Meeting held on 18 September 2017; the Ward Councillors were given an opportunity to advise on whether to add or subtract sectors on their respective Ward Committees and allow the Subcouncil Manager to initiate a process for elections in accordance with the rules.

It was agreed that a report be submitted to the ensuing Subcouncil Meeting (October 2017) for the Subcouncil to endorse the following recommendation:
