To decide on an application for extension of liquor trading hours in terms of Section 6(1) of the City of Cape Town: Control of Undertakings that Sell Liquor to the Public By-Law, 2013

#### 3. FOR DECISION BY

SubCouncil in terms of Delegation 4(2)

To approve, refuse or vary applications for extension of trading hours on premises where liquor licences have been granted.

#### 4. EXECUTIVE SUMMARY

The City of Cape Town: Control of Undertakings that Sell Liquor to the Public By-Law, 2013, was promulgated on 17 January and coming into effect on 01 February 2014.

An application for extension of liquor trading hours in terms of Section 6 (1) of the By-law was submitted to the Health Directorate and circulated to the relevant departments for comment. The fully signed application, including all required comments, was submitted to the SubCouncil 16 Manager, and was then circulated to abutting neighbours, all organisations included on the Ward 115 database and ward committee members for comment.

Clause 9 of the By-law requires that the City must, before approving an application for the extension of trading days and hours, reasonably and fairly consider further factors which must include, inter alia-

- (a) the validity of the liquor licence:
- (b) where applicable, the validity of a business licence issued in terms of the Businesses Act of 1991 (Act No. 71 of 1991);

- (c) location category as per the Schedule;
- (d) previous suspension, amendment or revocation of extended trading days and hours including previous records of complaints investigated and confirmed in respect of the last twelve months preceding a current application for extension;
- (e) the proximity of the licensed premises to surrounding residential zoned area, cultural, religious and educational facilities;
- (f) outcome of community consultation and the recommendation of the relevant ward;
- (g) the potential impact on the surrounding environment;
- (h) whether it is in the public interest to approve and grant an extension of trading days or hours; or
- (i) a motivation from the applicant dealing with the impact of -
  - (i) the risks to and nuisances on the surrounding community;
  - (ii) mitigation measures to assist the control of risks and nuisances; and
  - (iii) possible benefits of extended liquor trading hours and days on the surrounding community.
- (10) The basis and rationale behind all decision-making must be recorded.

#### 5. DISCUSSION

- 5.1 Section 6 (1) of the By-Law reads as follows:
  6(1) Subject to subsection (5), (6) and (7) a licensee may upon payment of the required fee, submit a written application to the City to extend the liquor trading days and hours of licensed premises.



#### **ANNEXURE B**

The Western Cape Liquor Act was approved after widespread public participation and it is submitted that it reflects the will of the people of the Western Cape.

The Western Cape Act provides for licence holders with off-consumption liquor licenses to sell liquor on Sunday (in areas where the municipality had not promulgated a bylaw regulating liquor trading days and hours).

It is submitted that the Control of Undertakings that Sell Liquor to the Public Bylaw of the City of Cape Town reflects the will of the citizens of Cape Town.

The Bylaw provides for licence holders with off-consumption liquor licenses to apply for Sunday trading.

Due to their working hours (also on weekends) and other commitments a significant percentage of the applicant's customers find it very difficult to purchase liquor weekdays and Saturdays.

Many of the Applicant's customers nowadays also choose to do their shopping on Sunday when they are not involved in the school activities of their children or their own sporting or social activities.

An amendment of the trading hours for the Applicant's store to include Sunday trading will allow them to purchase liquor with other products.

# THE PROXIMITY OF LICENSED PREMISES TO SURROUNDING RESIDENTIAL ZONED AREA, CULTURE, RELIGIOUS AND EDUCATIONAL FACILITIES

The manner in which the business is carried on under the current trading hours does not prejudice the residents of a residential area or the proceedings in cultural, religious or educational facilities and it is submitted that there is no reason why Sunday trading will change this situation.

#### THE POTENTIAL IMPACT ON THE SURROUNDING ENVIRONMENT

The current activities of the applicant do not have any negative impact on the surrounding environment and it is submitted there is no reason why Sunday trading will change this situation.

#### THE RISKS TO AND NUISANCES ON THE SURROUNDING COMMUNITY

The current activities of the applicant do not pose a risk or nuisance to the surrounding community and it is submitted there is no reason why Sunday trading will change this situation.

#### MITIGATION MEASURES TO ASSIST THE CONTROL OF RISKS AND NUISANCES

The applicant submits that its current activities do not cause risk or nuisance to the surrounding community.

No mitigation measures are therefore required.

However, should the applicant become aware of any risk or nuisance in future it will implement suitable measures to mitigate the risk or nuisance.

#### **PUBLIC INTEREST**

The proposed amendment to include Sunday trading will improve the shopping experience of the public by allowing customers time to purchase liquor on Sunday should this be the most convenient day for them.



- 5.2 The licensee and the manager must at all times ensure that the business is conducted in accordance with the liquor licence conditions and all legal requirements.

#### 6. NATURE AND CONDUCT OF THE BUSINESS

- 6.1 The licensee may sell wine, subject to 6.2, for consumption off the licensed area, as indicated on the attached approved plan.
- 6.2 Any liquor product sold on the premises:
  - (i) must be pre-packaged in a self-supporting container; or
  - (ii) if filled in a container which is not self-supporting, such container must
    - (aa) be pre-packaged in a self-supporting, non-returnable, tamper-proof outer packaging, which completely encloses and covers up that container;
    - (bb) be equipped with a sealed tap, which can be used in conjunction with the outer packaging;
- 6.3 Liquor packaged In "Papsakke" may not be sold.
- 6.4 No container may be opened and no liquor may be consumed on the licensed premises.
- 6.5 The nature of the business may not be changed from that approved by the Liquor Licensing Tribunal and or Presiding Officer without the prior approval thereof.
- 6.6 No liquor may be sold to persons who are drunk and / or disorderly.
- 6.7 No person who is drunk and /or disorderly may be allowed to stay on the licensed premises.
- 6.8 No liquor may be purchased from a person who is not allowed and licensed to sell that liquor.

- 6.9 No person, other than a licensee, may purchase, and a licensee may not sell to one person, in a single day to a person more liquor than that which the Minister may prescribe, without the prior written consent of the Presiding Officer of the Liquor Licensing Tribunal (Regulation 22, 2013 = 150 liters).
- No person may sell or supply liquor on credit, or receive or hold any document including any financial instrument such as a debit/credit card, social grant cards, identity documents or any other property as security for the payment of such credit.
- 6.11 No liquor may be sold to a person knowing or suspecting that such person will resell the liquor otherwise than is permitted in terms of the Western Cape Liquor or similar act.
- 6.12 The licensee and/or manager must at all times ensure that the activities and business conducted on the premises do not cause any nuisance or disturbance to others, including but not limited to neighbours, residents, other occupiers of buildings in the area and passers-by.
- 6.13 The licensee must ensure that the liquor licensed business is at all times conducted in accordance with all statutory and legal requirements, including all By-laws and regulations of the local authority.
- 6.14 The licensee must in the premises prominently display signs warning against the dangers of Ilquor abuse.
- 6.15 The licensee must, at the entrance to the premises, prominently display signs indicating that no under eighteens will be allowed and that proof of date of birth must be provided upon request.
- 6.16 The licensee must in the licenced premises, prominently display signage stating that it is an offence to:
  - drive while the level of alcohol that is higher than the prescribed limit, is still present in the blood stream;
  - for any person to consume alcohol in a vehicle driven or parked on a public road;
  - -for any person and the driver to have an open container with liquor in a vehicle driven or parked on a public road;
- 6.17 All signage and displays exhibited on or near the liquor licensed premises must where applicable comply with the statutes and regulations regulating same.
- 6.18 All products sold or supplied on the premises must be liquor products as defined in the Liquor Products Act, 1989 (Act 60 of 1989), or be beer as defined in this Act.
- 6.19 No bottling is allowed on the licensed premises.

- 6.20 Liquor may only be sold in a plastic container if -
  - (i) it is new plastic
  - (ii) It complies with the PET standards and requirements as prescribed by the Liquor Products Act of 1989, as amended, or any act by which it is replaced:
  - (iii) it has a "use by date" that does not exceed 3 months from date of bottling;
  - (iv) it is equipped with a sealed, tamper-proof cap;
  - (v) it has a capacity of not more than 5 liters
- 6.21 The Licensee/appointed manager shall ensure that liquor sold or supplied on the licensed premises, may not be consumed on the licensed premises at all, other than as allowed for in 17.3.
- 6.22 The Licensee/appointed manager shall not allow for the sale of liquor to patrons in containers which are not sealed. Liquor may only be sold in a properly sealed container, bearing the seal or label of a registered manufacturer or licensed micro-manufacturer.
  All containers with liquor must be sealed when sold and remain sealed when leaving the premises.
- 6.23 No substance of any sort may be added to liquor that is sold from the licensed premises.
- 6.24 No further fermentation may take place from the date of bottling/packaging till the date of consumption in respect of any liquor sold. The Alcohol content of the liquor sold, may not increase to a higher percentage per volume as from date of bottling/packaging till date of consumption, nor may it be higher than that as indicated on the label.

#### 7 DELIVERY OF LIQUOR (SECTION 50)

- 7.1 Liquor may not be delivered from any vehicle or any other means unless the liquor was ordered from the licensed premises in the exact quantity before the dispatch of the liquor and an invoice, the original of which was retained on the licensed premises, was issued in the prescribed manner;
- 7.2 Invoices must be issued in the manner prescribed by Regulation 20 of the Western Cape Liquor Regulations, 2011;
- 7.3 Liquor may be delivered only to the address shown on the invoice described in paragraph7.1;
- 7.4 A legible copy of the invoice described in paragraph 7.1 must be retained in the delivery vehicle from the time of dispatch to the time of delivery of the liquor, when it must be handed to the person accepting delivery;
- 7.5 Where the quantity of liquor being purchased is above the prescribed threshold, the purchaser must produce his or her liquor licence, identity document and provide bontact details as prescribed;

#### 10 PROHIBITION ON LIQUOR SOLD TO MINORS

- 10.1 The licensee or a manager may not sell, supply, avail or give liquor to a person under the age of eighteen (18) years.
- 10.2 The licensee and / or the manager or person in charge at the licenced premises MUST before any liquor is sold, ensure that the person to whom the liquor is supplied to, is above the age of 18 years.

#### 11 RESTRICTED AREA

The area licensed for the sale of liquor shall be regarded as a restricted area. Access to under eighteens is therefore restricted to the area licenced for the sale of liquor.

#### **12 TRAINING**

The Liquor Licensing Tribunal may, at any time when appropriate, direct that the licence may not be issued or should be suspended until the applicant or licensee or manager in terms of section 52, or an employee or employees of the applicant or licensee, has completed such training and education as the Liquor Licensing Tribunal requires on a date to be determined by the Administration. Not attending such training may lead to the review/suspension of the liquor licence.

#### 13 SALE OF LIQUOR

- 13.1 A licensee may not sell or supply liquor from any place other than the licensed area as indicated on the approved plan.
- 13.2 A licensee may advertise the sale of liquor and solicit and receive orders for the purchase of liquor elsewhere than on the licensed premises.
- 13.3 The advertisements and the signage must be in accordance with the applicable regulations and by-laws.

#### 14 SECURITY

14.1 The licensee must at all times be in proper control of the licensed premises and may not allow customers to bring any weapons or dangerous objects on the licensed premises.

14.2 The licensee must not allow a supplier of unlawful drugs to be or remain on the premises.

- 14.3 The licensee must not allow the sale, use or possession of drugs upon the premises in contravention of any law relating to such sale, use or possession.
- 14.4 The licensee must ensure that customers enter and exit the licensed premises in an orderly manner and take all reasonable steps to ensure the safety of customers in and around the premises and ensure proper control on and around the licensed premises.

#### 15 STORAGE

- 15.1 A licensee must store his, her or its liquor on the ilcensed premises or in such other or additional place within the Province as may be approved by the Liquor Licensing Tribunal when granting a license or by the Presiding Officer, on application, at any time thereafter.
- 15.2 A licensee may not sell, supply or allow the consumption of liquor in or from such other or additional place of storage.

#### **16 EMPLOYMENT**

- 16.1. A licensee may not employ a person under the age of eighteen (18) years in connection with the sale or supply of liquor.
- 16.2 An employer may not -
  - (i) supply liquor to a person as an inducement to secure his or her employment;
  - (ii) supply liquor to an employee instead of wages;
  - (III) deduct from an employee's wages the cost of liquor supplied to the employee or any other person on his or her behalf; or
  - (iv) withhold payment of the wages of an employee in lieu of a debt in respect of the sale or supply of liquor.

# 17 ACCESS TO THE LICENCED PREMISES BY DESIGNATED LIQUOR OFFICER AND LIQUOR INSPECTOR

A designated liquor officer and a liquor inspector may exercise the powers referred to in section 74 of the Act, relating to the entry, inspection and search of the premises at any time when the business is being conducted and at any time when business may be conducted in terms of the applicable by-law or hours as specified in these conditions.

On request from the licensee, manager or person in charge of the licenced prantaes the designated liquor officer or liquor inspector must identify him / herself.

Dear Sir/Madam,

We refer to the objection submitted by an unknown person on behalf of the St Martini Lutheran Church.

We contacted the office of the church and obtained confirmation that the church in question is located at 240 Long Street.

We attach a "Google" map which shows the location of the church as well as the location of the Woolworths store in respect of which the application for approval for extended training hours and Sunday trading was submitted.

We assume that the person which submitted the objection on behalf of the church was mistaken regarding the location of the Woolworths store in question as it is obvious from the plan attached that the store is located in the CBD of Cape Town. It is therefore incorrect to state that "this area is quite out of town and not a shopping area".

It is also obvious from the plan that wine sales in the store cannot have any effect on activities at the church (since the church and the store are located so far from one another).

In respect of the comment "there is no reason for selling alcohol here on Sunday" it is submitted that the bylaw in terms of which this application is made specifically makes provision for the holders of off-consumption liquor licenses to apply for an approval to sell liquor on Sunday.

It is also submitted that there is no reason why the Woolworths store in question should not be granted the approval taking into account that Woolworths has successfully applied for approvals to sell wine on Sunday for its stores within the Municipality since the bylaw was promulgated in 2014

In respect of the reference to "extra security for evening shopping hours" the objector does not provide any facts to explain why such security would be required. In this regard it is submitted that the record of Woolworths in respect of wine sales in terms of its approvals for extended trading hours and Sunday trading from 2014 confirms that no additional measures other than those currently in place at existing Woolworths stores are required.

Under the circumstances it is submitted that the objection - in so far as it can be considered an objection - should be disregarded.
