7. DISCUSSION/CONTENTS

The Covid-19 pandemic left many underprivileged communities without an income. A decision was made to utilize savings from ward allocation funds to create food relief programme, via the Mayor's special fund, to feed the underprivileged communities within the City of Cape areas

The Mayor's office paid an amount of R190 764 as indicated below from sub council 24 ward allocation savings to feed communities within wards.

- Ward 15 & 84 R55887 - Helderberg Uitreik, 150 vouchers issued.
- Ward 95 R44877 - Abakhanyisi Christian, 100 vouchers issued
- Ward 96 90 000 - Abakhanyisi Christian, 201 vouchers issued

It was decided that food vouchers be distributed to the intended beneficiaries by successful NGOs appointed by Mayor's office.

Ward 109 having an amount of R81588 reallocated to the Mayor's office, 186 food parcels were distributed by Sandy and Gabriella from SA SOCIETY OF HOPE organisation appointed by the Mayor's office.

A total number of 637 residents benefited from the food relief programme in sub council 24.
