**OFFICERS KILLED IN THE LINE OF DUTY**

*The Sub Council expresses its deepest condolences to the families, colleagues and friends of the two City Law Enforcement officers killed on duty this month. The two officers were shot and severely wounded while working in Philippi, defending the community and serving the people. Their loss affects us all and we wish their*

*families and loved one's comfort in their time of grief.*

### **VIOLENCE AGAINST WOMEN AND CHILDREN**

*The actions against domestic violence are continuing and the City's Metro Police and Social Development and Early Childhood Development Departments continue to host several programs and initiatives to curb domestic violence. All councillors are encouraged to promote these Social Crime Prevention initiatives and to make use of the Sub Council resources to do so.*

*Engagements with Alderman JP Smith, Mayoral Committee member for Safety and Security and Social Development and Early Childhood Development have already commenced in this regard and we will soon be receiving pamphlets regarding Domestic Abuse.*

*Men's role in the fight against Gender Based Violence cannot be overstated and the Men's Program, which was piloted earlier this year, is being rolled out to all Sub Councils and focusses on gender relations as shaped by culture, tradition and religion; substance abuse; HIV/Aids; parenting and cultivating positive role models.*

### **CRIME STATS**

*The crime statistics released this month dramatically illustrate the need for the return of the 4500 Police Officers the Western Cape is short of. SAPS and the Courts remain the primary agency in the fight against crime, but we all have a role to play. The City and Provincial Governments are proceeding with their fight for greater Provincial authority over SAPS, particularly when it comes to issues of deployment and resources. This would enhance the City and Province's contribution, which includes supporting Neighbourhood Watches, providing CCTV cameras and the Safety and Security Directorate's officers who support the SAPS in crime fighting.*

*A cursory glance at the statistics do illustrate the importance of Neighbourhood Watches in reducing crime, particularly when it comes to burglary at residential properties. The dramatic decrease in this offence in the Somerset West precinct from 1022 in 2017 to 780 in 2018 to 651 may well illustrate the importance of neighbourhood watches in the fight against crime, over and above the work being done by the Police, as they coincide with the growth in the number of neighbourhood watches within the precinct. The sub council will continue to support neighbourhood watches by providing equipment funded from ward allocation budgets, and training and support through the Neighbourhood Watch Liaison officers.*

### **RATES AND TARRIFS AND FINANCIAL ASSISTANCE TO RESIDENTS**

*The electricity tariffs were approved by the City's Council as part of the 2019/20 Budget after a public participation process which was held during April 2019. NERSA also approved the City's 2019/20 tariffs. In accordance with the Constitution of South Africa and local government legislation, namely the Municipal Systems Act and the Municipal Finance Management Act, a municipality may raise a surcharge on municipal services. Such a surcharge would be used to fund other services and would not be used to recover the costs of providing electricity. City's fixed charge not a surcharge, it is for cost recovery*

*As discussed during the engagement, the City's fixed electricity charge is not a surcharge and it was not introduced to generate extra income. The City's fixed electricity charge is used to recover the costs of providing electricity. It is not for*

profit or extra income for other services and it is thus regulated by NERSA. The 2019/20 fixed charge of R163,32 (including VAT) was approved by NERSA. The new City tariffs came into effect on 1 July 2019, which is the start of the new municipal financial year. No profit is made from the City's electricity income. Some 65% of the electricity tariff goes toward buying bulk electricity from Eskom. Eskom's tariff increased by 15,6% compared to the City's increase of 8,88%. The City compares well to other metros, with costs being lower in many instances.

The City has made considerable provision for vulnerable households and the elderly through the provision of rates rebates and indigent relief for thousands of residents. We continue to do our utmost as a City to cut costs and to keep affordability front of mind when tariffs are proposed, as set out below:

**The City of Cape Town encourages qualifying residents to apply for assistance with the cost of services and rates**

Pensioners who are 60 years and older who are already receiving these rebates are encouraged to re-apply as their three-year cycle ended in June 2019, following the new valuation of properties that has been implemented from 1 July 2019. Renewal applications have been posted to existing rates rebate recipients.

Property owners who are dependent on pensions or social grants for their livelihood, including those with disabilities, who earn up to R17 500 household income may qualify for rates discounts. This is a R2 500 increase in the monthly household income threshold for rates assistance. The rebates for all income bands between R4 500 and R17 500 per month were also adjusted upwards.

Furthermore, property owners who are indigent, who earn up to R6 000 a month, regardless of their age, are also encouraged to apply for indigent benefits that include rates rebates. In these challenging economic times, every bit of financial relief can go a long way to assist families and their budgets. Residents will need to meet various criteria to be considered for the City's indigent support, relating to their monthly income, employment status, whether they are a pensioner or receive a social grant, and whether they are a full-time occupant of their home. Don't struggle alone, make a payment arrangement.

Residents, who don't qualify for rates rebates or indigent benefits, but that are in arrears with their municipal accounts, do not need to struggle financially on their own. Representation can be made to the City for those who are struggling to pay their municipal accounts, to enter into an agreed arrangement/instalment plan to pay

- Certified copies of proof of income (not older than three months) for the owner and spouse/partner and three months' original, printed bank statements (non-internet statements) for all banking accounts from all banking institutions (not older than three months)
- Certified copies of ID of owner and spouse/partner
- Certified copy of lease agreement if your property or a portion of your property is being leased
- Certified copies of proof of pension (private and state pension)
- Certified copies of proof of investments or dividends
- Certified copies of proof of usufruct/habitation/executor/administrator or curator
- Certified copy of proof of trust document and income of all beneficiaries of the trust if applicable
- A certified copy of the applicant's ID and proof of income for all owners is required if the property is registered in the names of multiple owners; together with a certified power of attorney permitting the applicant to act on behalf of the other owners in respect of the specific property
- A certified copy of the applicant's (person residing) ID and certified proof of income for all other members if the property is registered as a close corporation (CC); in addition, a certified letter permitting the applicant to act on behalf of the other owners in respect of the specific property

## **ECONOMIC GROWTH AND TOURISM**

*The Sub council plays a key role in encouraging tourism and in this tourism month we have seen the focus shift to more localized tourist attractions such as curated routes tour in Khayelitsha to engaging with members of the newly established Helderberg Tourism Forum. Alderman James Vos, the Mayoral Committee member of Tourism and Economic Development has indicated his willingness to see tourism being expanded throughout the metro, with a particular focus on heritage and natural attractions which occur throughout the sub council. The sub council will continue to engage with residents involved in the tourism sector as we seek to grow and expand this important economic driver.*

## **MOTIONS AND MATTERS RECEIVING ATTENTION**

*Ward councilors are bringing more and more motions to sub council and these issues in their wards are dealt with at the monthly sub council activity days. Report backs to the community will continue to be done via the ward committees and residents are urged to attend and to engage with the representatives of the various sectors in the wards.*

## **PROGRESSIVE CAPITAL EXPENDITURE AND BUDGET CONSULTATIONS**

*We are 3 months into the new financial year and the report to the sub council on progress with implementing the new capital budget serves before each monthly sub council to enable monitoring of the budget spend. These reports are also sent to the ward committees so that the public can be kept aware of progress in their areas. Over and above that, the report back and budget consultation meetings this past month have been well attended and the Sub Council is already embarking on the process of considering inputs from these meetings for the next Financial Year's budget.*

## **HOUSING**

*The City of Cape Town has 28 social housing projects in the planning or construction phases and five social housing projects have been completed to date. Its commitment to affordable housing, including Gap-, social-, inclusionary- and affordable market housing in and near urban centres aims to develop a greater spatial equality in Cape Town. There are a number of housing projects in progress or due for commencement in this financial year, including in Khayelitsha, Macassar, Lourenzia Park in Somerset West and Sir Lowry's Pass Village and the sub council is monitoring these to ensure that houses are allocated fairly, in terms of the City's policies and that neither councilors nor any community leaders are involved in the allocation of housing. Besides these projects, the sub council is also working with City officials around upgrading of informal settlements, identification of additional land for further housing projects and handing over of title deeds to residents.*

*One of the major challenges facing residents is the acute shortage of affordable accommodation for those who earn above the threshold to qualify for a housing subsidy but earn too little to qualify for a bond and the Sub Council has begun engagements with the City around how to address this need. The South African Human Rights Commission's Backyarder Summit was held this month in Cape Town. The sub council welcomes the spotlight being placed on the plight and concerns of backyard dwellers that are often not eligible for government subsidised housing due to higher income earnings or their more youthful age. It is fitting that its*



*Summit has been held in Cape Town as this metro was the first in the country to provide backyarder services to those residing as backyarders on Council-owned property. Residents on the City's waiting list are urged to engage with their respective ward councilors regarding housing developments in their areas and to regularly update their details at the nearest municipal housing office. ## **ENVIRONMENT**

*Managing the City's biodiversity in the face of climate change, and providing education and action to conserve our natural resources are all part of the mandate of the City's biodiversity management department and the Sub Council continues to monitor their work as we do this month via their annual presentation. The City has focused this Arbor month not only on planting trees in the sub council, but also on education programs via schools. While the draft coastal by law was well publicized by the media's focus on the provisions against foul and abusive language on beaches, there is a great deal more to this draft by law. Of course, the media houses probably thought the public would be less interested in the provisions around preserving the environment, making beaches safer and more family friendly, but these were the issues highlighted in the recent round of public engagements held in the Sub Council.*

*Finally, the City's Marine and Environmental Law Enforcement Unit, which was established in 2013 to fight the illegal extraction of marine resources along the City's 300km coastline, has added an eighth rubber duck to its fleet.*

## **24SUB MATTERS RECEIVING ATTENTION 5/9/2019**

- The Chairperson stated that most of the outstanding matters was dealt with at the Activity Day meeting held on Wednesday 18 September 2019. The decisions that were taken at the meeting will all go onto the minutes and all Cllrs were in agreement with the proposal made by the Chairperson.
- The action that needs to be taken by the various Cllrs that it be forwarded directly to them as a reminder.
- Goodman Rorwana raised a few MRA's that was not dealt with at the Activity Day meeting which is as follows:
- Cllr Peck stated that at the Activity Day meeting the officials of Roads & Stormwater and Recreation & Parks mentioned that their Department do not have term tenders and not sure when the tenders will be renewed. Roads Department also mentioned the tender for speed calming will expire in December 2019.
- Goodman Rorwana stated that an email has been received from his Director indicating that the Department is preparing a deviation report and in the process

of having a new tender in place is underway. He will forward the traffic calming tender email to all the Cllrs.

**Motion No. 23, Item 24SUB 13/10/18**

**Motion received from Cllr Gregory Peck that the Subcouncil approach the Transport Development Authority Department to investigate the development of 4 rows of parking bays on the area known as the Rose Garden, Somerset West**

- Melani Ohlson of Transport Department reported that the existing park and ride opposite the Police Station was established through the Transport Department. The park 'n ride currently being used by Golden Arrow bus commuters use transport frequently to Cape Town and at this stage the parking is sufficient for the particular usage. She is not sure what this request is for and she has liaised with Roauwhen Thomas who gave her background on this matter.
- Cllr Peck responded that he has engaged with Western Cape Heritage as well as the City's Heritage Department and looking at redesigning the park. It is partly for parking but the idea is to create more parking for Bright Street and patrons that use the restaurants around there and especially over weekends then the area is full of parked cars. They also want it to be user friendly and get the old machine from AECl as the ground was donated by them. They are planning to and EIA study and to change it into a water wise area as well as soft paving and making it nice. He said this will take time and needs to be planned so that budget can be set aside.
- Melani Ohlson responded that the area belongs to Recreation & Parks Department and not Transport Department and anything that needs to be done there should be rezoned for the required usage. Her department do not create parking for public usage they only provide park 'n rides for commuters that uses Golden Arrow Bus Service to park their cars.

- Cllr Peck responded that the taxis stop right there in the middle of the road in both directions and the taxis block the major intersection where Waterstone Shopping complex and the Lord Charles Hotel. He said there are two bus stops on the other side of the road. Not sure how they will convince the commuters to use those bus stops and that the taxis pick them up there cause at the moment the taxis pick them up in front of the entrance to the Lord Charles and Waterstone Shopping Centre. He is willing to speak to the property owners as their employees use the taxis. He also proposed that an impact study need to be done on this.

**24SUB 9/9/2019 PROGRESSIVE CAPITAL EXPENDITURE: AUGUST 2019**

**Ward 15**

**CCTV Cameras**

- Cllr Peck enquired on last year's cameras as to when will they get approval from Eskom and when will the camera be installed. He also stated where he wanted the camera at Steynsrust Bridge to be installed cannot be placed there because there is no line of sight to be linked to the control room in Goodwood and wanted to know if he wants a PTZ camera whether that is able to link to the control room at HCW and not to Goodwood because the LPR camera does not do the job.
- Kevin Cole of CCTV responded that the LPR cameras work on a different operational system which is more on a 3G system. The PTZ camera cannot stream video over a 3G as there need to be a line of sight to whatever control room it is going to be linked to. He doubts whether it will be linked to Goodwood but maybe to the control room in the area if there is clear line of sight.
- They had problems with Eskom and this has taken time but have now resolved and they are starting to connect to those cameras.

- The Chairperson requested a detailed report to the Subcouncil on all the CCTV cameras which have been installed in all five wards since 2017 funded from ward allocation and where they are controlled from.

#### **Ward 84**

- The Chairperson was covered by the CCTV cameras reported in Ward 15.

#### **Ward 95**

#### **Construction of Park – Zwelitsha**

- The rollover funds have been committed to complete the Park.

#### **Upgrade of Parks**

- Sipumelele Mbusi of Recreation & Parks reported that the R500 000 was allocated for the upgrade of Dongwe Park that a meeting has been set up with the Ward Cllr to discuss the progress.

#### **Public Transport: Makhaza Bus Facility**

- Melani Ohlson provided a background on the project as there was a new Ward Cllr elected in Ward 95. She stated that the project originated as one project and then the implementation overlapped in Ward 96 and their Department decided to break up the projects i.e. in Ward 95 the bus facility and in Ward 96 the mini bus taxi facility.

They had to appoint a panel of consultants and currently going through a section 33 and this should be concluded by November 2019. They will review the previous work that was done in conjunction with the Ward Cllr.

#### **Nazeema Isaacs Library**

- Lunga Vani of Libraries provided feedback and reported that they purchased study guides and everything is on track.

#### **Sidewalk Construction**

- Siphiso Xhalisi of Roads & Stormwater provided feedback and reported that the contractor is nearing completion. Processing part payment of the invoice. The outstanding letter that needs to be signed will be issued to the house on the corner. This won't be immediately as there are legal issues that need to be addressed.
- Cllr Khatshwa wanted to know why is the Department treating this one differently as they had dealt with the same issue in the past and what is their fear.

- Siphiso Xhalisi responded that he did raise the matter with his senior and they did not have any written agreement with the home owner. They want to follow due processes for the home owner to remove her illegal structure and a letter will be issued to the home owner soon.
- Cllr Khatshwa responded that he resolved this with the home owner in a manner that they have found common ground and agreed that the owners do not want sidewalks but rather paving. He will wait on the Department's process and the time frame and that it should be monitored.

#### **Public Transport: Makhaza Mini Bus Taxi**

- Melani Ohlson reported the comments reflected on the PCER is still the same that the appointed contractor has not been able to provide the required performance guarantee and the site has not been handed over and no work has commenced. The matter has been referred to Legal Services and have not received any feedback from them. This is a concern for the Transport Department as they can't proceed with the project until they get clarity from Legal Services. Anele Viti has been keeping the Cllr updated with progress made.
- A public meeting will be arranged and that Melani Ohlson provide the Subcouncil with a report.

#### **Festive Lighting**

- Clinton Hartogh of Energy Department provided feedback of the R70 000 that was allocated and the funds was committed. The commencement of the project will start around mid-November 2019 to mid-January 2020 that the funds will be spent.
- Cllr Khatshwa raised a concern that all motifs need to work when the festive lights are switched on.
- Clinton Hartogh responded that if the street lights do not work then the festive lights won't work either.
