PURPOSE

For the Subcouncil to approve the recommendation for an application for the extension of liquor trading hours in terms of Section 6(1) of the City of Cape Town: Control of Undertakings that Sell Liquor to the Public By-Law, 2013.

4. FOR DECISION BY

Subcouncil in terms of Delegation 4(2)

To approve, refuse or vary applications for extension of trading days and hours on premises where liquor licences have been granted in terms of Section 2 of the Bylaw: Control of Undertakings that Sell Liquor to the Public, 2013.

5. EXECUTIVE SUMMARY

The City of Cape Town: Control of Undertakings that Sell Liquor to the Public By-Law, 2013, was promulgated on 17 January and coming into effect on 01 February 2014.

An application for extension of liquor trading hours in terms of Section 6 (1) of the By-law was submitted to the Health Directorate and circulated to the relevant departments for comment.

The fully signed application, including all required comments was submitted to the Subcouncil 3 Manager, and was then circulated to abutting neighbours, all organisations included on the **Ward 113** database and ward committee members for comment.

Clause 9 of the By-law requires that the City must, before approving an application for the extension of trading days and hours, reasonably and fairly consider further factors which must include, inter alia-

- (a) the validity of the liquor licence;
- (b) where applicable, the validity of a business licence issued in terms of the Businesses Act of 1991 (Act No. 71 of 1991);
- (c) location category as per the Schedule;
- (d) previous suspension, amendment or revocation of extended trading days and hours including previous records of complaints investigated and confirmed in respect of the last twelve months preceding a current application for extension;
- (e) the proximity of the licensed premises to surrounding residential zoned area, cultural, religious and educational facilities;
- (f) outcome of community consultation and the recommendation of the relevant ward;
- (g) the potential impact on the surrounding environment;
- (h) whether it is in the public interest to approve and grant an extension of trading days or hours; or
- (i) a motivation from the applicant dealing with the impact of -
 - (i) the risks to and nuisances on the surrounding community;
 - (ii) mitigation measures to assist the control of risks and nuisances; and
 - (iii) possible benefits of extended liquor trading hours and days on the surrounding community.
- (i) The basis and rationale behind all decision-making must be recorded.

6. DISCUSSION

- 6.1 Section 6 (1) of the By-Law reads as follows:
 6(1) Subject to subsection (5), (6) and (7) a licensee may upon payment of the required fee, submit a written application to the City to extend the liquor trading days and hours of licensed premises.
- 6.2 The following application for extension of liquor trading hours in terms of Section 6 (1) of the By-law has been received by the Subcouncil:

 - INTERNAL DEPARTMENT:
 - Safety & Security (Liquor Control):

Pertaining to the mentioned premises namely Shoprite Liquorshop, Parklands, situated at Shop 11, 4 Parklands Main Road, Parklands, Table View. It was ascertained that the applicant did renew his Liquor Licence for 2019. No complaints were received by the Liquor Unit with regards to this establishment. This application was submitted to the Provincial Office of SAPS' Liquor Control for comments, however, no feedback has been received.

RECOMMENDATION

It is recommended that the Subcouncil **consider** the application for the renewal of extended trading hours (off-consumption) Monday to Saturday 18:00 to 20:00 and Sunday 11:00 to 18:00 trading submitted by Shoprite Liquorshop, Parklands, situated at Shop 11, 4 Parklands Main Road, Parklands, subject to the following conditions:

- A. That the application for the renewal of extended trading hours (off-consumption) submitted by Shoprite Liquorshop, Parklands, situated at Shop 11, 4 Parklands Main Road, Parklands, Table View, be considered as it complies with the criteria included in the City of Cape Town: Control of Undertakings that Sell Liquor to the Public By-Law, 2013.
- B. Should complaints be received concerning noise and/or unruly behaviour of patrons, these complaints will be investigated and may result in the extended trading hours being withdrawn and will also be referred to the Western Cape Liquor Authority which may jeopardise the renewal of the liquor licence.
- C. The applicant must ensure that no sale of liquor is made directly to or via a third party to unemployed and/or homeless persons occupying public open spaces in the vicinity of Shoprite Liquorshop, Parklands, situated at Shop 11, 4 Parklands Main Road, Parklands.
- D. This application is also subject to compliance with all relevant by-laws of the City of Cape Town.
- E.This application will be valid for 12 months from the date of the decision subject to the possession of a valid liquor licence.

AANBEVELING

A. Dat die aansoek om hernuwing van verlengde drankhandelsure (buiteverbruik) ingedien deur Shoprite Liquorshop, Parklands, geleë in winkel 11, Parklandshoofweg 4, Parklands, Table View, oorweeg word aangesien dit voldoen aan die kriteria van die Stad Kaapstad: Verordening oor die Beheer van Ondernemings wat Drank aan die Publiek Verkoop, 2013.

- B. Indien klagtes oor geraas en/of wilde gedrag van kliënte ontvang word, die klagtes ondersoek sal word en daartoe kan lei dat die verlengde handelsure teruggetrek word en na die Wes-Kaapse Drankowerheid verwys word, wat die vernuwing van die dranklisensie kan belemmer.
- C. Die aansoeker moet toesien dat geen drank direk of via 'n derde party verkoop word aan werklose mense en/of hawelose persone wat op die openbare oop ruimtes in die omgewing van Shoprite Liquorshop, Parklands, geleë in winkel 11, Parklands-hoofweg 4, Parklands woon nie.
- D. Hierdie aansoek is ook onderworpe aan voldoening aan alle toepaslike verordeninge van die Stad Kaapstad.
- E. Hierdie aansoek geld vir 12 maande vanaf die datum van die besluit onderworpe aan die besit van 'n geldige dranklisensie.
