Cllr P Heynes further stated that the request from the Mayco Member: Urban Management for the submission of road potholes and resurfacing should be sent to the Transport Department for assessment, to determine whether these are the same roads and whether the state of these roads are worsening.

Cllr S Oerson enquired around the return of staff for the Transport Department that attend to pothole and road repairs as skeleton staff is still in place and serious concern around the staff shortage. RM

RM stated that each department needs to report on their return to work.

Cllr S Oerson also stated that every year there is an overflow in 3 houses because of the Canal in Kleinvlei. She requested that an urgent site visit be conducted with the Subcouncil Manager, Chairperson and all relevant role-players to have a practical look at the reoccurring problem within the area- and to consider a permanent solution to the problem at hand. She said the canal was much higher than the properties and when the canal blocks up the water overflows into the abutting properties.
