Cllr asked all the ward committee members to go and read themselves all the motions and come back with understanding.

Motion No. 21 Item 24 SUB 24/3/2018

Motion received from CIIr Danile Khatshwa to provide a report on possible solutions to the dangerous situations for residents crossing Japtha K Masemola Road between Thubelitsha Homes and 31 Section, Makhaza, Khayelitsha.

- Cllr Danile Khatshwa gave a brief overview background of this projects and said, the area is not safe, people get knocked by the cars when crossing the road. Many accidents happened in that level crossing. Hope this traffic measure will be able to minimize the level of accidents.
- The construction of un-signalized level crossing and bump out will be implemented to minimize the speeding of vehicles in order to allow the pedestrians to cross safely.
- R200 000 has been allocated for the project and will be implemented before the end of June 2019.

Motion No. 21 Item 22 SUB 25/3/2018

Motion received from Cllr Danile Khatshwa regarding the vandalized white prefab structure to be utilized by the senior citizen's club

 The item is still under investigation and must REMAIN on the Matter Receiving Attention minutes until such time it is completed. An NGO needs to be identified amongst the community to look after the structure. The structure must be utilized by the Senior Citizen club.

Motion No. 23 Item 24 SUB 26/3/2018

Motion received from Cllr Danile Khatshwa that the Sub council engage with the Transport Development Authority Department (TDA) to investigate the possibility of erecting traffic lights at the intersection between Baden Powell, Japhta K Masemola & Macassar roads

- The motion is to put traffic lights at the intersection between Baden Powell Drive and Japtha K Masemola next to Macassar. The matter is still under investigation.
- Mr Zwele commented that people of Khayelitsha are really struggling when it is peak hour then as motorist they are unable to join the intersection.

Motion received from Councillor Danile Khatshwa that the Subcouncil engage with the Transport Development Authority Department (TDA) to investigate the possibility of erecting traffic lights at Walter Sisulu and Lindela roads, Makhaza, Khayelitsha

- The public meeting will be held to inform the community as well as UKITA leadership since they are going to be affected by this.

Motion received from Councillor Danile Khatshwa that the Subcouncil engages with the Electricity Department and Eskom to investigate possible ways to electrify some of the households at Emsindweni informal settlement, Makhaza, Khayelitsha.

The community of Emsindweni Informal Settlement have lodged a complaint that they need additional toilets, the toilets seats, handle and the flushing handles are broken. Cllr D Khatshwa requested Mr Xuba to send an email to the line department about the request and nothing has been done.

Motion received from Councillor Danile Khatshwa that the Sub council engage with the City of Cape Town: Area Based Directorate

to investigate the possible completion of the container structure that were erected at the term of 2006 to 2011.

- The Cllr D Khatshwa mentioned that there is no space for ambulance to park. Patients get seen by everyone when go out with an ambulance from the clinic and it is very embarrassing seen.
- Mr Zwele also mentioned that there is no wheel chair ramp at the clinic.
