The following salient points were noted:

- 1. Cllr M Adonis expressed her gratitude with the current progress at the Delft Informal Trading Bay, but raised the concern that ERF 17683 is up for auction whereby 5 trading bay's will be built and requested if those 5 bays can be moved to a different location.
- 2. Clir X Ndongeni stated that concerns were raised from community members where they have indicated that the bays are too small and also that in some areas like Sandalwood where implementation of the informal trading bays is yet to start.
- 3. Mr. Mogale indicated that there is a dispute between the communities with regards to what the land is initially earmarked for and also the issue raised by Cllr(s) that the site with ERF 17683 is up for sale, which will include the construction of 5 Trading Bays and mentioned he only implements approved plans undertaken by the Council and indicated that he will then need to raise this issue with Council as the authority is with Council only to advise. He further mentioned that the budget for the construction of the Trading Bays is available but it does not allow for all sites to be implemented at the same time.
- 4. Chairperson C van Wyk further requested the city manager that the decision for the Implementation of the Delft Trading bays was passed by council and would like to request clarity if this issue must be address with council again.
- 5. Mr. Mbandazayo stated that council should make the decision with regards to the auction of ERF 17683 whether to sell the property or to build on it.
- 6. Chairperson suggested that the Subcouncil should put the construction of the 5 Trading Bays on hold until the matter is resolved.
