3. PURPOSE

The purpose of this report is to provide an update to the Subcouncil on the feedback received from Directorates on the capital and operating budgetary requirements as identified by the Subcouncil.

5. EXECUTIVE SUMMARY

Subcouncil's System of Delegation Part 24: 2 (3) provides for Subcouncils to make representation to the relevant line departments for the inclusion of capital and operating budgetary requirements.

On the 29 May 2019, Council approved (item: SPC 29/05/19) the IDP and Budget Time Schedule, in accordance with the Municipal Finance Management Act 21(1), which states the City is required to submit an IDP/Budget timeline to Council 10 months before the start of the new financial year. As per the time schedule, a report served at Subcouncils in September 2019 requesting Subcouncils to provide structured and strategic input for inclusion of the 2020/2021 Operating and Capital Budget.
