Registration as a Production Company in the City of Cape Town

The City of Cape Town has introduced a single entry point when applying for permissions to shoot on municipal property anywhere in the City of Cape Town.

This is applicable to all entities wishing to apply for permits for film-related activity in the city, including students.

ALL permit applications will be required to be made through City of Cape Town Film Permitting Office (CTFPO).

In order to make use of this system, all Production Companies must register with the City of Cape Town Film Permitting Office, and furnish the following information.

- Production Company Registration Form
- Indemnity Form*
- Copy of Public Liability Insurance
- Company Letterhead

N.B.

1. **We need the original Indemnity Form to be submitted to our office.*
2. *Production Companies are to submit the name and details of a Company Verification Contact Person. The Verification Contact Person is to be assigned as the primary contact to verify/confirm user registration, permit applications, location reservations, etc. on the Online Locations Reservation System.*
