1. PREAMBLE

- 1.1. Whereas this Addendum is entered into between the City of Cape Town and Hyve Events South Africa (Pty) Ltd (herein referred to as the "the addendum"), to effect amendments to an Events Agreement between the parties that was signed on 2 December 2019, whereby the CITY agreed to make certain funding available to the RECIPIENT, (hereinafter referred to as the "Agreement").
- 1.2. Whereas the parties wish to make amendments to the Events Agreement as set out in this Addendum, the Addendum contains certain terms and conditions which the Parties have agreed to vary in order to reflect more correctly the intention of the Parties.
- 1.3. The purpose of this addendum is to amend the company name and bank account details in which the Recipient will be accepting receipt of the allocated support funding.

2. PARTIES

The Parties to this Agreement are:-

- 2.1 The **City of Cape Town**, (hereinafter referred to as "**the CITY**") a Metropolitan Municipality established in terms of the *Local Government: Municipal Structure Act, 1998, (Act No. 117 of 1998)* read with the Province of the Western Cape: Provincial Gazette 5588 dated 22 September 2000, (as amended), herein represented **Mr Richard Bosman** in his capacity as the **Executive Director: Safety and Security**; and
- 2.2 **Hyve Events South Africa (Pty) Ltd** is a company registered in terms of the law of the Republic of South Africa with **registration no: 2004/009544/07** (hereinafter referred to "**the RECIPIENT**") herein represented by **Mr Nathaniel Hirsch** with **passport number 485377744** in his capacity as duly **Authorised Signatory**, duly authorised hereto.

3. INTERPRETATION

- 3.1.1 This Addendum forms an integral part of the Events Agreement and all the provisions of the Events Agreement apply to this addendum *mutatis mutandis* and all terms defined in the Events Agreement have the identical meaning in this Addendum.

3.1.2 This Addendum shall be read as if incorporated into the Events Agreement and shall be construed as an addendum to and not a novation of the Events Agreement.

3.1.3 Save as expressly recorded in this Addendum, the Events Agreement shall remain unchanged.

4. DEFINITIONS

4.1. In this Addendum words and phrases defined in the Agreement or in the annexures to the Agreement will bear the same meaning herein;

4.1.1 "**Addendum**" means this addendum agreement;

4.1.2 "**Events Agreement**" means the agreement entered into between the Parties in year 2019/20 relating to Event/Sponsorship Agreement;

4.1.2 "**Parties**" means the Parties to this Addendum.

5. VARIATION OF AGREEMENT

5.1 The Events Agreement is hereby varied as follows -

5.1.1 That the name of the Recipient in clause 1.2 of the Events Agreement be changed from **ITE Events South Africa Pty Ltd (Registration number: 40402144746)** to **Hyve Events South Africa (Registration number: 2004/009544/07)** a company duly registered in accordance with the laws of the Republic of South Africa with its registered address at Autoparks House, 13 Park Crescent, Glenhazel, Gauteng and herein duly represented by **Mr Nathaniel Hirsh** in his capacity as **Sales Manager**.

5.1.2 The bank details of the Recipient be changed as follows:

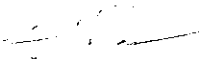
