SCMB 06/12/19 PROCUREMENT OF GOODS/SERVICES/CONSTRUCTION WORKS FROM ANOTHER ORGAN OF STATE: THE PROCUREMENT OF VACCINES AND EMERGENCY MEDICINES

In response to questions raised regarding the consent letter from the Western Cape Government, the meeting was informed that this request is for a direct procurement. The officials explained that the contract is part of a National Tender from which items are procured through National Treasury.

The officials requested that the contract period be adjusted to terminate on 30 June 2022 in line with the Agreement attached to the report.

RESOLVED that for the reasons set out in the report and in accordance with clause 20.1 of the CCT's SCM Policy, the Western Cape Government: Health Cape Medical Depot be appointed for the procurement of vaccines and Emergency Medicines, from date of commencement of contract until 30 June 2022, as follows (excl. VAT), plus an allowance for contract price adjustment in accordance with the terms of contract, and Rates of Exchange variations for the goods and equipment to be imported:
