		<u>Flight - definitions</u>								
		Planned Flight: Pre-planned flight is planned at least 18 hours in advance and having a distinct purpose and an identifiable area of operation allowing for appropriate resourcing and flight planning.								
		Unplanned Flight: Ad-hoc or Emergency flight which is not pre-planned but based on unforeseen activities. This flight is required on an urgent basis with a wheels up of 60 or 30 minutes respectively.

EXEMPTIONS/CONCESSIONS:										
1.1 The Manager of EPIC in consultation with the Executive Director Safety and Security may agree not to charge in cases where charges have been levied erroneously. Criteria for exemptions/concessions: Parties must make written application to the Executive Director: Safety and Security; Outlining the reasons why charges were levied incorrectly and why exemptions/concessions should be considered.										
1.2 The Executive Director in consultation with the respective departmental heads may reduce all tariffs and fees as approved by Council for this Directorate up to a maximum of 50% of the actual amounts to be billed. All applications for such reduction to be submitted in writing to the office of the Executive Director: Safety and Security. All decisions made in terms of such authority to be reported to the Office of the City Manager. The Executive Director: Safety and Security may increase this waiver up to 100% of the amounts billed. All decisions made in terms of increases in excess of 50% are to be reported to the Portfolio Committee within 3 months.
