Cllr P Gabriel advised that the Independent Electoral Commission (IEC) had in error indicated in the Gazette that Cllrs Hanekom and Knox were still NNP members while they were in fact now ANC members. A letter from the IEC dated 22 September 2004 was tabled (copy attached as Addendum B) indicating that the IEC would publish a correction notice in the Government Gazette on 22 September to rectify the matter.

1 EXECUTIVE SUMMARY

In terms of Sub-Section 29 (3)(a) of the Local Government Municipal Structures Act 1998 (No. 117 of 1998) the Speaker is required to convene a meeting, or meetings of Council for the purpose of dealing with (amongst others) the consequences of a change in the composition of the Council, as a result of the application of Schedule 6B to the Constitution. The first of such meetings must be held within 7 days of the termination of the period referred to in Item 4(1)(a)(ii) of Schedule 6B. (The period having commenced on 1 September 2004 and expired on 15 September 2004)
