It is hereby recommended that:

- (a) Council delegates to the Executive Mayor the authority to appoint a person to apply the criteria set out in sections 24 and 25 of the Local Government Municipal Demarcation Act No 27 of 1998 in so far as they can be applied and to consult with the Demarcation Board on proposals to group adjoining Wards into Subcouncils;
- (b) The person so appointed by the Executive Mayor thereafter submits to Council a recommendation in this regard;
- (c) The person so appointed by the Executive Mayor prepares and submit a draft amended Subcouncil By-law to Council consistent with his or her recommendation.




