#### 4. DISCUSSION

The South African Local Government Association (SALGA) had invited the city to nominate a councillor and an alternate to represent the City of Cape Town on the SALGA Women's Commission.

The SALGA Women's Commission (SWC), was established and launched in 2010 at the Women in Local Government Summit. This was followed by the establishment and launch of provincial chapters. Its directive is to coordinate, promote and advocate for suitable practices and strategies within member municipalities.

The Western Cape SWC operates within the constitutional and governance prescripts of SALGA and the terms of reference makes provision for each municipality to nominate a political representative and an alternate to serve on the Provincial SALGA Women's Commission.

By direction from the Chief Whip, Councillor Desiree Visagie, Cllr Arlene Adams is to be removed from the SALGA Provincial Women's Commission.

Councillor Geraldine Gordon will replace Councillor Arlene Adams as the primary member on the SALGA Provincial Women's Commission. An alternative has not been identified as of yet.
