16SUB 47/1/2020: MOTION OF EXIGENCY: "HIGH CAPE DEVELOPMENT UNDERPASS" RENAMED INVESTIGATION OF SAFE ACCESS OF UPPER CITY BOWL TO THE CAPE TOWN CBD

- Meeting was held on the 13th August 2024 with representatives of Network management (Deon Manuel and Sean Glass)
- They presented a draft proposal for the upgrading of the intersection which included the realignment of the road as well as the installation of traffic lights at the intersection of Phillip Kgosana and Cressula
- However, the draft proposal will be the subject of a peer review with other colleagues in Urban mobility to assess its feasibility
- Once approved by the technical peer review panel, the proposal will then be taken out for public participation planned for November
- CIBRA will be given an opportunity to present other intersections that needs to be looked at.

16SUB 40/5/2021: MOTION OF EXIGENCY: THE ROSEBANK HORSE FOUNTAIN

- Site meeting was arranged between the SC, officials from Arts & Culture, Heritage, RIM and an external organization called the Cape Town Heritage Foundation
- Feedback from Mark Bell Report served at Heritage Western Cape for the upgrading Horse Fountain. Heritage Western Cape requested that further specialist studies be undertaken. Heritage department is in the process of appointing service provider to complete these studies which will include the proposal for the replacement / upgrading of the horse fountain, new location and realignment of the road and costings
- It was agreed that on the 24th of November 2024 we should have a decision from Heritage Western Cape as to whether the fountain will be replaced or fixed
- RIM: Enrico Bell from RIM indicated that they will look at the designs and will
 do the upgrades and costing of the project. They will also fund the upgrading
 of the intersection from their own internal budget
- Roads also agreed to store the Horse fountain during the implementation of the project.
- Arts and Culture indicated that the scope of the upgrading of the Rosebank Horse Fountain, falls outside of their mandate of Monuments and Memorials
- Manager: Arts & Culture have been engaging with Cape Town heritage
 Foundation to explore the possibility of them funding the upgrades
- The Cape Town Heritage Foundation indicated that they are willing to look at the request depending on costs.

 He is going to arrange a meeting with the Director: Property Management to initiate that process but still pending feedback.

- The Area Manager indicated that funding is available for maintenance at the facility. However, the tender to implement these repairs is only available until till December 2024

Clinton Manual introduced the report and opened the floor for questions.

Cllr Mohamed thanked Clinton for the comprehensive report, however, indicated that not all information included is pertinent for our Subcouncil. The request is to refine it and gear it towards Subcouncil 16 and then include thigs like fire hydrant maintenance, etc.

Cllr Higham requested an update on the fencing at Roeland Street Fire Station and Clinton responded by indicating that quotations were received for the repair, however, the service provider on the tender is charging almost 5 times more that another quote received from another service provider, received via a request for quotation process and therefore, it is being reviewed.

Ald Kempthorne advised that this matter of exorbitant quotations be reported/ escalated for investigation.

Cllr Ah-Sing enquired about a school listed under the education section of the report as he does not recognize the school mentioned and Clinton explained that the stats are as a result of visits from or to schools, however, he will need to investigate and later advise Cllr Ah-Sing.

Clinton indicated that they are starting with roofing repairs and the ablutions have been completed. Cllr Higham pointed out that all repairs should meet heritage requirements and Clinton confirmed that they are working with heritage. Cllr Mohamed enquired how the building works will affect operations, where Clinton responded that there will be no effect as it is on a different floor and they may simply move things around where required.

Cllr Ah-Sing identified that Brooklyn Fire Station requires assistance as they are quite busy but have a list of repairs to be done – Clinton will review.

Cllr Higham outlined that the process was presented at FOCOS but is now with Ease of Doing Business Portfolio – the SC and Ward Cllr is expected to manage the process, however, Sean Glass was tasked to review the entire process. The process was presented at a previous SC Activity Day where actions were set, however, no responses have been received to date.

- a) Main Drive and Glengariff Road are Class 5 Local Streets located within a medium-density residential area of Sea Point.
