4. DISCUSSION

The IDP annual amendment process commenced during September 2020. All Councillors will be informed of the amendment process via Management News and are given the opportunity to submit proposals.

2021/2022 is the <u>last year of the IDP</u> five-year plan and should ideally focus on maximising of performance and the delivery/implementation of programmes and projects contained in and imperative to the IDP.

Making progress possible. Together.

It is recommended that the IDP be reviewed in light of the Mayor's Strategy Brief which highlights areas for prioritisation for the coming financial year for the organisation, given the impacts of the COVID-19 pandemic. Furthermore, the severe fiscal restraints within which the City will operate for the foreseeable future should be a key consideration when reviewing the IDP and when making proposals for amendments.

This **annual review** process is a legislative requirement according to the Municipal Systems Act No. 32 of 2000, Section 34 (b) and identified in the Council approved IDP and Budget Time-schedule in May 2020. The review process may identify amendments that are required.

The process of **amending** the IDP is prescribed in Section 3 of the Municipal Planning and Performance Management Regulations, 2001. During this process a member or committee of a municipal council has the opportunity to submit a proposal for amending the IDP. Any proposal for the amendment of the IDP must include a memorandum which provides a reason for the proposal.

A template which ensures that legislative requirements are complied with is attached (Annexure A) and should be completed for all proposed amendments to the IDP. The due date for proposals (completed memos) is on or before the 31 October 2020 and must be submitted to idp@capetown.gov.za.
