#### 3. PURPOSE

The Subcouncil to note the exercising of sub-delegated authority in respect of event and / or temporary liquor licence applications in terms of the Western Cape Liquor Act, 2008, as amended.

#### 4. FOR DECISION BY

The Subcouncil resolved on 23 March 2022 vide 15SUB15/03/22 inter alia that:

- (a) The Subcouncil Manager or Acting Subcouncil Manager, in consultation with the chairperson and affected ward councillor, be authorised to exercise powers, functions and/or duties delegated to the subcouncil in terms of Part 24 of Council's System of Delegations, as approved by Council on 18 November 2021:
  - (i) In the event of subcouncil delegation 4(1) which authorises the subcouncil to comment on applications for liquor licences in terms of the Western Cape Liquor Act, 2008, as amended, and which due to time constraints cannot be submitted to one of the scheduled subcouncil meetings for consideration, the subcouncil manager or acting subcouncil manager, in consultation with the chairperson, and affected ward councillor be authorised to deal with and finalise such matter;

#### 5. EXECUTIVE SUMMARY

Delegated authority conferred *vide* 15SUB15/03/22 (a(i), b and c) with regard to delegation 25.4(1) have been exercised after following the prescribed public consultation process by consulting the relevant Ward Councillor and Subcouncil Chairperson.

It should be noted that according to the Western Cape Liquor Act, as amended, the municipality only has 8 days to provide comment. In cases where the municipality has not provided comment, the Western Cape Liquor Authority may make a determination without considering the input of the municipality.

Attached hereto, as **Annexure A**, are the recommendations forwarded to the Western Cape Liquor Authority in terms of the Western Cape Liquor Act, 2008 as amended for the period December 2022 to March 2023.
