## 5. EXECUTIVE SUMMARY

The C3 Notifications report is a standing report on every Subcouncil agenda.

At the Activities Day meeting of 14 March 2017, the Subcouncil Councillors attended a training session regarding C3 notifications which included the process as to how to extract information from the SAP System.

The Councillors at the meeting on 14 March 2017 unanimously agreed that they would visit the Sap Portal on a regular basis and bring any queries regarding outstanding matters to the Activities Day each month, for further follow-up by the Subcouncil Manager.

Report back will then be supplied at the Subcouncil meeting of the same month.

In incidents where the Activities Day may be cancelled for any particular month, it would be on the Councillor's onus to submit outstanding matters of concern to the Subcouncil Manager for further follow-up.

This report is submitted to enable Councillors to monitor service delivery in the respective Wards of Subcouncil 3 for the period 1 June 2021 to 30 June 2021.

For July 2021, 3544 notifications were created, 3143 notifications were closed and 401 notifications are outstanding and in progress for Subcouncil 3.
