CHAIRPERSON'S REPORT

Ald Sotashe welcomed the Subcouncil 09 members and the officials to the meeting.

Bulk infrastructure in the City is the cause of concern and everything has been done from the side of Subcouncil 09. Cllr Pietersen has reported that the issue of gangsters in Beacon Valley has taken another turn, even met with one of the community members while doing oversight in Khayelitsha with Minister Mbalula three days ago in making sure that the unrest that is taking place in Kwazulu Natal and Gauteng does not happen in Khayelitsha, said Ald Sotashe. It has come to attention that there is stoppage of refuse collection and services in the informal settlement and that resulted in heated argument with the office of the speaker.

Ald. Sotashe went on by saying that contractors are facing challenges when they deliver services to the communities because of some fellows who are claiming their stake and if contractors refuse they make the life of these contractors miserable. He mentioned that he spoke to Mayor and raised some of the concerns that councilors have and he gave a commitment to talk about these issues. The visit was done in Site B but the community will not trust the leadership if such keeps on happening. The spillage is another issue and he cannot come and create impressions that his presence will make a difference as the problem is the underground infrastructure. Directorate to speak to each other in terms of servicing the communities. He also reported that the Chief Justice recommended that the election will be postponed until February 2022 and the IEC will announce the results. Councillors to work hand in hand until the end of the term and good luck to them.

Cllr Nqulwana – understanding of the same City of Cape Town is different from what is happening on the ground, water and sanitation report is part of today's meeting and there are departments with in such but there is no commitment from other flushing vs bucket system toilets. When a visit is done by the department, Mayor and chairperson, the community should take ownership of the services but in this case, they are not aware.

Chairperson – commitment was done that the community be informed of the services so to take the ownership of the services and he will follow up with such departments.

MATTERS RECEIVING ATTENTION

Cllr Nqulwana commented that the Subcouncil should keep other MRAs as is but to take a different approach for memory centre as we have lost R1.5m. the site is there but needs a political wheel which needs engagement of MAYCO to assist.

Ald. Sotashe – an engagement to continue with the ward involved and the Arts & Culture Department with challenges that have been encountered between now and the next Subcouncil meeting

SEWER ACTION PLAN SITE B AND C

Ald. Sotashe commented that as the members of the Subcouncil are aware of the challenges within the are – what is the action plan in terms of resource including human resource going forward.

Response – teams are struggling in terms of safety and security when it comes to

escorting, tried communities to accompany the teams but should something happen to the escorted, the department will be held liable or be reimbursed.

Ald. Sotashe – these are the reasons not to respond, the Mayor explained that the communities should meet the city half way and they confirmed that they will be part of the process as nothing will happen in their presence. The response shows no partnership with the communities as it tells that they have difficulties with safety and security and that should be engaged from the directorate and the person's name must be shared and not use conspiracy.

Mr. Matiwane commented that on the 24th June Site B community demanded to meet the department urgently, six people came to the depot and mentioned that it is not their responsibility to safe guard the department and in need of EPWP to work on the programme.

Ald. Sotashe – it seems that there is no action plan for Site B and Site C and therefore refer the report back until the plan is in place.

Cllr Mpengezi – no action plan as the informal settlement (sewer) is secured by private securities, law enforcement is a challenge but that is not a problem as he and Cllr Jali went to the ground with them for two months and nothing happened. There are areas that needs attention in terms of overflowing (E & F section) manpower is the issue as he is always available to assist them, make sure that contractors that are specializing in the spillage/trucks thy would not be in this situation as the depot is responding but the problem seem to be with the management.

Cllr Maxiti – what plans do they have in terms of reimbursing the escorts. It was a call for people to assist when the problem arises but the department did not communicate with councillors as they took the decision for community to assist. Are there any services available to assist as the service has to be done?

Cllr Nqulwana – if management does not take responsibility of what is happening in the ground, the project manager will take the punch while the issue is out of his hand. The need for special meeting is displayed by this reporting so to have all the departments involved, there is no connection between informal and formal areas, from Site C station to RR to N2 and Zandvlei is clear but struggling within Site C and Site B connection, the submitted plan does not talk to the current situation. While delaying the progress, sewer is spilling to peoples house and foreseeing major problem.

Cllr Jali – the areas are so bad and the community is insulting the councillors due to situation, they have availed themselves to be part of the program.

Mr. France – an increase in both site b and c has led the current situation, the plan does not talk to plans and not addressing the situation (background vs....)

Ald. Sotashe – page 31 refers to Urban Management with no department and not saying how are they going to address what has been diagnosed.

Mr. Nogaya – contributions noted and the department will work according to submissions and submit the action plan by the end of business on Monday, 26th July 2021
