**5. EXECUTIVE SUMMARY**

SALW is the brainchild of the Library & Information Association of South Africa (LIASA) to market Library Services across the sector to the broader community, civil society and decision-makers. In Library and information Services LIS, SALW is an annual opportunity to highlight the role that public libraries play in advancing literacy, providing free access to information and empowering communities. LIS uses the opportunity to recover overdue material. SALW will run from 20 - 25 March 2023.

It is recommended that the Sub Councils support Library & Information Services in their efforts to retrieve overdue library material by informing their communities about Fine-Free Week and actively encouraging people to return overdue library material.

## **7. DISCUSSION/CONTENTS**

As part of South African Library Week, LIS concurrently runs an Amnesty Week commonly known as Fine-Free Week. This initiative aims to retrieve overdue library material from library patrons who are encouraged via various communication platforms to return their overdue library items to their local library, preferably to the library where the item was borrowed. Our current annual losses for the year stand at 39,508 items with a value of R4,6 million.

The top 10 outstanding books are:

- The getaway Kinney, Jeff (23 copies)
- The meltdown Kinney, Jeff (23 copies)
- Physical Science. Grade 12, study guide (22 copies)
- Cinderella Davidson, Susanna (20 copies)
- Dog days – Kinney, Jeff (19 copies)
- Double down Kinney, Jeff (19 copies)
- Accounting. Grade 12, study guide (18 copies)
- Life of Pi by Yann Martel Grade 12 English Literature study guide (17 copies)
- The last straw – Kinney, Jeff (17 copies)
- Life sciences. Part 1. Grade 12, study guide (16 copies)

The LIS Marketing and Communications unit will promote SALW on various platforms to return material, including the online public access catalogue (OPAC), social media platforms, municipal bills and staff desktop screens, etc. with the indication that no fines will be payable on overdue material during this week. Posters can be provided by this unit to all Sub Council offices to assist with the promotion of this event.

The objective is to inform as many people as possible regarding the LIS initiative. Books are extremely expensive and the current book budget does not adequately provide for the need in the department for new material. Material that is not returned rob other members of the community of the opportunity to benefit from the material. Once returned, the library material can then be utilized by other library patrons
