2. SUBJECT

3. PURPOSE

To request that Subcouncil 24 engage with City Health Department to investigate three possible sites in Ward 96 boundaries i.e. erf no. 42776 Nyanda Avenue adjacent to Sinako High School, erf no. 59037 cnr Dibana & Cekeca Roads, erf no. 41463 cnr Mpompoza Street and Nyanda Avenue for the construction of the new proposed Matthew Goniwe Clinic and that the report be tabled in the Subcouncil 24 meeting.


