5. EXECUTIVE SUMMARY

The Western Cape Liquor Act, 2008, as amended by the Western Cape Liquor Amendment Act, 2010 and Western Cape Liquor Regulations, 2011 were implemented on 1 April 2012. In terms of the Act, certain obligations were put on the City Manager. The City Manager ruled that all applications for liquor licenses received within the City be received at a central venue and delegated his authority to the Manager: Sub councils to receive such applications from the various Designated Liquor Officers.

6. DISCUSSION

- 6.1 Section 37 of the Act address the Notice of Application process.
 - "(4) The designated liquor officer in whose area of jurisdiction the proposed licensed premises are located must, within the prescribed period from the date of lodgment of an application, serve a copy of the application in the prescribed manner on the municipality concerned in order for it to—
 - (a) where section 36(1)(c) applies—
 - (i) allow the public to have access to, inspect or, upon payment of the prescribed fee, obtain a copy of the application:
 - (ii) obtain the comment of the ward councillor.
 - (iii) comment on the application; and
 - (iv) allow for the consideration of the planning application in relation to the application for a liquor licence; or
 - (b) where section 36(1)(c) does not apply—
 - (i) allow the public to have access to, inspect or, upon payment of the prescribed fee, obtain a copy of the application;
 - (ii) obtain comment of the ward councillor; and
 - (iii) comment on the application.

- 1. TEMPORARY LAND USE DEPARTURE GRANTED INTERMS OF SECTION 98 OF THE MUNICIPAL PLANNING BY-LAW
- 1.1 Temporary land use departure to permit a liquor shop/off-sife consumption on a portion of the subject property.
 - 2. CONDITIONS TO BE IMPOSED IN TERMS OF SECTION 100 OF THE MUNICIPAL PLANNING BY-LAW AS PART OF THE TEMPORARY LAND USE APPROVAL

DEPARTMENT: PLANNING AND BUILDING DEVELOPMENT MANAGEMENT

- 2.1 This approval is granted for a period of 5 years only.
- 2.2 The operator must be the owner of the subject property and must reside on the subject property.
- 2.2 The permitted use will be limited to a liquor shop/off site consumption facility only.
- 2.2 That the extent of the activity shall be limited to the 26m² portion of the existing dwelling as indicated on drawing no Gobingca09014. Building in accordance with the aforementioned plans, indicating the temporary use areas, shall be submitted within one month of receiving the final approval of this application.
- Delivery vehicles delivering goods to liquor shop shall not exceed 3500kg. 2.3
- No juke box or loud music shall be permitted on the premises. 2.4
- The use permitted shall only operate between 08:00 and 21:00 from Mondays to 2.5 Sunday.
- 2.6 A refuse bin shall at all times be placed at the entrance to the property for the use of patrons/customers and the owner shall ensure on a daily basis that the street is kept clean within a 50m distance from the subject property.

- Delivery trucks, patron vehicles or vehicles owned by the applicant shall not obstruct traffic or obstruct the entrance to the driveway of neighbours.
- 2.8 Signage will be erected by the operator at the liquor shop to discourage lollering by patrons of the liquor shop.
- 2.9 The operator shall not be allowed to consume alcohol during business hours while operating the liquor shop.
- 2.10 The alcohol sold on the premises shall not be sold per glass and only in the original enclosed container of the manufacturer.

STANDARD HEALTH REQUIREMENTS

- 2.10 The Noise Control Regulations P.N. 627/1998 as promulgated under the Environmental Conservation Act, 1989 (Act 73 of 1989) by not creating a disturbing noise and/or noise nuisance to surrounding property owners.
- 2.11 Should the premises be used for a category of business which is required to be licensed in terms of the Business Act, No 71 of 1991 i.e. sale and supply of meals, health and entertainment, etc, then application must be made for the relevant business license. Should food be prepared or handled, then application must also be made for a Certificate of Acceptability for food premises in terms of Regulation R962 dated 23/11/2012 promulgated under the Foodstuffs, Cosmetics and Disinfectants Act, No 54 of 1972. These requirements come into effect once the City has approved the land use application.
- 2.12 The owner/lessee/operator shall ensure compliance with the provisions of the Tobacco Products Control Amendment Act 12 of 1991.

SOLID WASTE MANAGEMENT

2.13 Council's standard requirements and guidelines pertaining to the removal of solid waste and refuse storage facilities shall be complied with.


- 1) Compliance with the Noise Control Regulations P.N. 200/2013 as promulgated under the Environment Conservation Act, 1989 (Act 73 of 1989) by not creating a disturbing noise and/or noise nuisance and/or exceeding the `50dBA limit for machinery in residential areas`. Any noise producing plant or equipment must be adequately muffled so as not to create a disturbing noise; a noise nuisance or exceeding the 50dBA limit for machinery in residential areas.
- 2) Should the premises be used for a category of business which is required to be licensed in terms of the Business Act, no 71 of 1991 i.e. sale and supply of meals, health and entertainment, etc. then application must be made for the relevant business license. Should food be prepared or handled, then application must also be made for a Certificate of Acceptability for food premises in terms of Regulation R962 dated 23/11/2012 promulgated under the Foodstuffs, Cosmetics and Disinfectants Act, No 54 of 1972. These requirements come into effect once the City has approved the land use application.
- The premises must be made to comply with the requirements of the Tobacco Products Control Act, 1993 (Act No 83 of 1993) and Notice Relating to Smoking of Tobacco Products in public places, Regulation No R975 dated 29 September 2000. In this regard, guidelines for the design of designated smoking areas and requirements for artificial ventilation that serves smoking areas can be obtained from the City's local Environmental Health Practitioner.
- An integrated waste management approach must be used that is based on waste minimization and should incorporate reduction, recycling, re-use and disposal where appropriate. Any solid waste shall be disposed of at a landfill site, licensed in terms of Section 20 of the Environmental Conservation Act, 1989 (Act No 73 of 1989).
