# 75WC6/4/2023 CHAIRPERSON'S REPORT

The Chairperson addressed the meeting as follows:

"Good afternoon everyone and welcome to our meeting this afternoon."

Thank you for accommodating the change of date, as I was unable to attend the meeting as scheduled last week.

At our last meeting held the 16 February, we congratulated Petor Fashions for an excellent and successful Fashion Show and today I want to congratulate them on the commencement of their sewing classes that kicked off. To Noel for the continued services that he and his team is delivering by feeding those less fortunate and to the rest of team thank you for your services within the community.

Load shedding has become something that is ruling our lives and we have to schedule and re-schedule as the announcements is made to what level we are at. The Rondevlei area has once again experienced longer load shedding due to the breakers that is affecting the power stations. Our businesses is feeling the effect as they have to struggle along with the continued load shedding. We all the Shut Down but once again the City of Cape Town with relevant stake holders stepped, all safety services was visible and ready for any unlawful activities.

We have arranged SASSA to bring their services to the community and we have scheduled to have SASSA at our Woodlands Community Hall on Tuesday 21 March 2023, but due to vandalism, they could not service the community. They have however assured us that once the cables and power is restored, they will be rendering their services. The continuous threats by Mafias on City Developing sites has cost the life of one of City employees in Delft where a million Rand was offered as a reward to arrest those perpetrators . Our bridge came under siege as well when gangsters threatened workers and contractors, security was put in place and the work continued as we observed and visited the site yesterday. On Saturday 18 March I was alerted that there was hundreds of invaders at our housing project ready to move in. SAPS and all relevant safety structures was alerted and they acted swiftly together with the residents of New Woodlands that never allowed anyone to invade the homes. On Monday those who was on site visited my office to hand over a Memorandum of Demand to stop the beneficiaries from moving in. a special meeting to deal with this is scheduled for Wednesday 22 at 17h00 at the Northwood Community Hall.

We have had challenges with rehabilitation/ re-surfacing of Jakes Gerwel and had an urgent site visit to resolve the issues at hand. The community must understand that with developments and upgrades comes discomfort, but this will only last for a season.

We had upgrades at Magnolia Park, where the play area was rubberized and the walkways upgraded with MURP funding that was allocated. We await the schedule for storm water drain cleaning before we reach the winter months to prevent the flooding of our roads that occurs. The month of February was a


