3. PURPOSE

The purpose of this report is to seek the support of Subcouncil 8 to endorse the proposed operational projects to be funded from R 1,9m allocated per Subcouncil for 2022/23

5. EXECUTIVE SUMMARY

An amount of R 1,9 million has been made available in the 2022/23 budget for Subcouncil operational projects. Councillors and officials from line departments were requested to submit project proposals, which could make a difference in visible service delivery in the approved Mayoral Urban Regeneration Project areas

and other targeted areas across the Subcouncils. The proposals were discussed with and considered by the Subcouncil Chairperson on 13 June 2022.

6. **RECOMMENDATIONS**

It is **RECOMMENDED** that:

- (a) Subcouncil 8 **SUPPORTS** the proposed operational projects to be funded against the R 1,9m Subcouncil Operational Projects Budget for the 2022/23 financial year.
- (b) Subcouncil 8 **MANDATES** the Subcouncil Manager to negotiate with the line department regarding the 99% expenditure of all allocated funding at the end of the financial year.

I would like to request on behalf of Ward 86:

Repairs to Sikhwenkwe Recreation Center which comprises of a community gym, old age center, performing arts youth centre and ECD. This space caters for youth from Ward 85 & 86 because it is the only recreation City building in the area.. The various programs at the centre are: gym (weightlifting and exercise) boxing, karate, performance arts, preschool, old age center. The soccer, netball and rugby sport codes that are utilising sport field also make use of the gym.

Overall amount required to address some of the challenges at the facility such as plumbing repairs, electrical repairs & securing the building = R700 000 to address the criteria below

My proposal:

- 1) R310 000 towards each ward (15, 83, 84, 85, 86, 100)
- 2) R40 000 towards Sub-council clean-up project in our parks/ POS's

Five possible options to consider in ward 83 (depending on budget allocation):

- 1) Fencing of POS in Victoria Park, Klampenborg road. (will assist in safety concerns and walkthrough, as well as damaging of city property in POS, like the soccer turf)
- 2) Closing of walk through area in Helderzicht, near 1 Monte Vista Crescent and also the first 3 outer boundary walls of the properties next to walkthrough. (will reduce crime and improve safety concerns in the community)
- 3) Security measures on vibracrete wall in Linpark to prevent persons jumping over wall from one side to the other (will reduce criminal activity, as this area is an escape route for criminals)
- 4) Removing of dilapidated/ broken fence next to the Lourens river and the clearing of the bushes on the river bank between Beach road and the ocean (this area between the broken fence and the river is a hide out for criminal activity and is used from time to time as sleeping place for vagrants)
- 5) Fixing of the pole fence in Dune Park, Beach road, next to the sand dunes and the replacement of the wooden paths over the sand dunes (this will protect the sand dunes, the vegetation on the dunes and keep visitors of the sand dunes)

Other projects I'd like funding for:

- Mobile internet
- Gordons Bay & Gustrow Sports Field:

- o This includes the demolishing of the small old building and the building of a newer, bigger and more modern facility where perhaps there is even space for Badminton.
- The revamp and modernisation of all stands
- o The revamp of the netball and basketball courts.
- The revamp of the rugby field.
- The revamp of the cricket field.
- o The revamp of the soccer field.
- Astro turf for hockey
- o The creation of a jungle-gym and outside fitness gym.
- o More floodlights.
- The modernisation and gentrification of the Gordons Bay beachfront
 - o This includes the installation of permanent toilet and changing facilities
 - o This includes landscaping of the parking lot.
 - o More waste disposal facilities, especially along the beach front all the way towards Harmony Park.
 - o Repairing (and getting switched back on) of the outside rinse off showers.
 - Funding for the Beach Restoration Programme
 - Wheelchair access ramps into the water. These can be of the plastic nature which are rolled out and removable. An example of such is in Muizenberg.
 - o Wooden walkway parallel to the dunes from the old harbour to the new harbour.
 - Continuous walkway from end to end, blended with current infrastructure.
 - CCTV camera system to be installed along this walkway.
 - Lookout platforms along regular intervals along this walkway.
- The repairing and closing off of the fencing of the public facilities
- Fleur Park needs to be fenced off from the dunes.
- Hiking trails:
 - Upgrading and widening of the Protea hiking trail on mountainside which links to the Danie Miller trail.
 - o Safety upgrade and widening of the Dannie Miller trail, the unsafe portion.
 - o Platform with map and lookup binoculars at the top of the trail.
- Stairway between 181 and 183 beach road
 - O Needs to be fixed so that it can be usable again
- More trees in the ward
 - Neat rows of trees along major roadways
