### 5. EXECUTIVE SUMMARY

An amount of R1.9 million is being made available on the 2021/22 budget for Subcouncil operation projects. The report provides the MURP background as a backdrop to inform the selection of the operational projects and seeks the support of Subcouncil 5 to endorse the Operational projects.

A workshop with Ward Councillors was held on 11 May 2021 to consider possible projects which could make a difference in visible service delivery in the approved MURP areas and other targeted areas across the Subcouncil.

#### 6. RECOMMENDATION

It is recommended that:

a) Subcouncil 5 identify projects for the R1 900 000 MURP budget allocation for the 2021/22 financial year and submission to MURP.

### 7. DISCUSSION/CONTENTS

MURP was established in 2012. It is an amalgamation of two similar programmes which were implemented in the Metro South East, namely: Violence Prevention through Urban Upgrading and the Presidential Urban Renewal Programme. The first generation of MURP areas targeted previously disadvantaged and neglected areas as sites of MURP implementation.

The overall objective of MURP is to improve safety and quality of life by crowding and coordinating investments in strategic geographic areas. MURP's methodology is area based and spatial targeted, and areas of intervention are mainly public spaces, shared spaces and public realm.

An amount of R1.9 million per Subcouncil is being provided for the 2021/22 budget to advance MURP strategic objectives. There is no guarantee that the same operational budget will be received in the next financial year, therefore projects proposed for funding should commence and be completed in this current fiscal year.

The funding is for projects that will create safer neighbourhoods, regenerating the environment and communities, improving and refurbishing existing public spaces and facilities, stabilizing areas and providing a platform for effective investment and driving active and engaged communities

The purpose of this report is for the Subcouncil to recommend projects for the implementation of the R1 900 000,00 allocation from the MURP funding in the 2021/22 financial year.

## 7.1 Constitutional and Policy Implications

The implementation of this project is in alignment with the MURP methodology as approved by Council Resolution C24/12/14 dated 8 December 2014.

SUBJECT: Urban Management 2020/2021 Budget

Dear Colleagues,

On 27 May 2020, the 2020/20201 Budget for the City of Cape Town was approved in Full Council.

Included in this was the Urban Management budget for Capital and Operational Expenses.

A total of R48 million was allocated to MURP for the 24 Subcouncil identified projects, amounting to R2 million per Subcouncil.

Subcouncils are therefore requested to urgently, in conjunction with ward councillors and line departments, start with project identification.

It is encouraged that Subcouncils focus on projects that not only create a safe community, but also attend to regenerating our communities:

- i. Creating safer neighbourhoods
  - community identified pedestrian routes
  - improved lighting
  - Security hardening closing off unsafe walkways 'gangetjies', creating secure courtyards within CRUs with security walls, including hard surfacing, washing lines, recreational areas
  - Safety Ambassadors EPWP
- ii. Regenerating the environment and communities
  - Area cleansing and the introduction of community based recycling projects to turn illegal dumping into an opportunity.
  - Bush clearing
  - Planter boxes / community gardens

- iii. Improving and refurbishing existing public spaces & facilities
  - Colour and Public Art a community generated alternative to graffiti, especially on security walls and also through the introduction of colour to CRUs and the walls and boundary walls of public facilities to brighten up communities and to create individuality and hope.
  - Broken windows strategy within the busy spaces in communities and wards
- iv. Stabilising areas and providing a platform for effective investment
  - Public facilities fixed well maintained and positively activated / used during high risk times by the community and the youth.
  - Attractive and popular youth spaces, as well as platforms for new artists, safe space for youth, activation of community spaces, positive childhood development and a competitive brand to re-identify dangerous communities as more than simply 'violent'.
  - Offer a safe and attractive space for youth as well as a developmental program for children.
- v. Driving active and engaged communities
  - Sport and Recreational Programs (soccer, basketball, boxing, yoga)
  - Arts and Educational Programs (poetry, writing, homework, drama, art, dance)
  - Early Childhood Development Support

When identifying projects please bear in mind that projects should be realistic and implementable under the different COVID-19 alert levels. A project plan should accompany each identified project with a clear approach for each COVID-19 alert level (1-5). This requires us to think out of the box and adopt new, innovative and improved approaches.

Colleagues I trust I can count on your support in ensuring we deliver for all residents.
