5. EXECUTIVE SUMMARY

The PICID falls within the boundaries of Subcouncil 6 (Ward 22).

The SRA By-law, 2012, as amended, reads as follows:

11(4) "Every sub-council, having full or partial jurisdiction over a special rating area, must nominate one Councillor as an observer and one other Councillor as an alternate observer of the management body."

11(4A) "The Executive Mayor of the City shall, after receiving sub-council nominations, appoint one or two Councillor(s) and one alternate Councillor for each Councillor appointed as observer, to serve on the board of the management body."

Councillor Rose Rau has raised concerns regarding her continued involvement with the CID given her new political role and has requested that the Subcouncil reconsider her as an Observer / alternate Observer.

As the PICID falls within Subcouncil 6 (Ward 22), Subcouncil 6 is required to provide the Chief Whip with nominations for a Councillor, as an observer and alternate observer to attend the PICID management body meetings.

The Chief Whip in consultation with the Executive Mayor will affect the appointment by the Executive Mayor.

6. RECOMMENDATIONS

Not delegated: for decision by the Subcouncil:

- a) That Subcouncil 6 nominate a Councillor and an alternate to attend the Parow Industria City Improvement District Association management body meetings as observers.
- b) That the names of the political representatives be submitted to the Chief Whip to effect appointment by the Executive Mayor.

The SRA By-law 2012, as amended reads as follows:

Clause 11(4) - "Every sub-council, having full or partial jurisdiction over a special rating area, must nominate one Councillor as an observer and one other Councillor as an alternate observer of the management body."

Clause 11(4A) – "The Executive Mayor of the City shall, after receiving sub-council nominations, appoint one or two Councillor(s) and one alternate Councillor for each Councillor appointed as observer, to serve on the board of the management body."

Councillor Rose Rau has raised concerns regarding her continued involvement with the CID given her new political role and has requested that the Subcouncil reconsider her as an Observer / alternate Observer.

As the PICID falls within Subcouncil 6 (Ward 22), Subcouncil 6 is required to nominate a Councillor, as an observer, to attend the PICID management body meetings and an alternate.

These nominations must be forwarded to the Chief Whip who will, in consultation with the Executive Mayor, effect the appointment by the Executive Mayor.


