5. EXECUTIVE SUMMARY

This Safety Plan is a defined framework for the understanding of and engagement, followed by a specific topic. A safety plan, therefore, is a framework for understanding and engaging with matters relating to the safety of GUNYA Area, place or space.

This safety plan seeks to guide implementing stakeholders / partners in identifying risk factors that may be undermining the levels of safety within their specific communities, that of GUNYA, while also providing a preventative factor for the actioning of this information in a manner that is tangible and real outcomes focused.

With the rapid of increased crime globally, and the western cape, and in particular the GUNYA precincts, the need for the management of crime prevention became inherently clearer, through a process of commitment

to supporting communities in the development initiatives and through efforts of preventing and combating crime, for safer communities. This was a direct result to the development of the GUNYA Safety and crime prevention plan, which is aimed and expected to provide focused direction to GUNYA communities for the purposes of crime prevention and combating thereof.

This plan specifically focused on GUNYA, municipal suburbs of Cape Town, South Africa. While the methodological framework and logic of analysis may find applicability more broadly, the plan itself is based on local data and therefore cannot be abstracted from the context of GUNYA, and should not be seen as representative of any other community or place, no matter how similar in dynamics.
